- 15 master's in business administration from the University of Georgia's Terry College of
- 16 Business; and
- 17 WHEREAS, he served his community on the Rabun County Development Authority and
- 18 Rabun County Convention and Visitors Bureau, in addition to running the Dillard House; and
- 19 WHEREAS, John Peter Dillard was united in love and marriage to Louise S. Dillard, and
- 20 was blessed with two remarkable children, John E. Dillard and Natalie Dillard Cross, and
- 21 four wonderful grandchildren, Maya Dillard, Connor Dillard, Dillard S. Cross, and Blaire
