- 1 Honoring the life of Judge Larry Salmon and dedicating an intersection in his memory; and
- 2 for other purposes.
- 3 WHEREAS, Judge Larry Salmon was born on March 29, 1938, in Rome, Georgia, graduated
- 4 from Armuchee High School, and spent his life serving and loving his community; and
- 5 WHEREAS, Judge Salmon earned his bachelor's degree and Juris Doctorate from the
- 6 University of Georgia, where he was a member of the Alpha Tau Omega fraternity; and
- 7 WHEREAS, he worked with the Parker, Clary & Kent Law Firm before he served as
- 8 assistant solicitor and assistant district attorney; and
- 9 WHEREAS, Judge Salmon served as the Floyd County District Attorney from the early
- 10 1970s until 1984 and took the bench as a superior court judge in 1989; and
- WHEREAS, he served as served as superior court judge for almost 20 years until his
- 12 retirement and, upon his retirement, went on to serve as a senior superior court judge for over

14 WHEREAS, during his career on the bench, Judge Salmon earned a reputation as a clear

- 15 thinker and hard worker, as a man whose strong convictions were supported by meticulous
- 16 research and careful consideration, and as an equitable, impartial leader whose decisions
- were governed by the rules of honesty and fair play; and
- 18 WHEREAS, Judge Salmon was well known throughout the Armuchee community for his
- 19 knowledge of local history and was well respected by the entire community; and
- 20 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
- 21 Georgian be recognized appropriately by dedicating an intersection in his memory.
- 22 NOW, THEREFORE, BE IT RESOLVED AND ENACTED BY THE GENERAL
- 23 ASSEMBLY OF GEORGIA that the intersection of State Route 1/U.S. 27 and Little Texas
- 24 Valley Road in Floyd County is dedicated as the Judge Larry Salmon Memorial Intersection.
- 25 BE IT FURTHER RESOLVED that the Department of Transportation is authorized and
- 26 directed to erect and maintain appropriate signs dedicating the Judge Larry Salmon Memorial
- 27 Intersection.
- 28 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized
- and directed to make appropriate copies of this resolution available for distribution to the
- 30 family of Judge Larry Salmon and to the Department of Transportation.
