- 3 WHEREAS, Deb Bailey has long been recognized by the citizens of this state for the vital
- 4 role that she has played in leadership and her deep personal commitment to the welfare of
- 5 the citizens of Georgia; and
- 6 WHEREAS, she has diligently and conscientiously devoted innumerable hours of her time,
- 7 talents, and energy toward the betterment of her community and state as evidenced
- 8 dramatically by her superlative service with the Northeast Georgia Health System; and
- 9 WHEREAS, she graduated from the Hall School of Nursing in 1974, earned her bachelor's
- 10 degree in psychology and nursing from Brenau University, and graduated Summa Cum
- 11 Laude with her master's degree in nursing from the Medical College of Georgia; and
- 12 WHEREAS, Deb began her professional career over 43 years ago during a time when
- nursing and health care, as a whole, shared a very different paradigm than they do today; and
- 14 WHEREAS, she began as the head nurse in a psychiatric drug and alcohol unit, and she later
- became an associate professor of psychiatric nursing at the Hall School of Nursing; and
- 16 WHEREAS, as the health care system became more advanced, Deb played a large role in the
- 17 evolution of women in the health care work force, working as a Computers In Nursing
- 18 Consultant, which enabled her to travel the world and be one of the first women to ever speak
- 19 in public in the United Arab Emirates, and serving on the editorial board of the first ever
- 20 nursing journal devoted to computers in nursing; and

21 WHEREAS, Deb's career eventually advanced into health care administration; she served

- 22 in the position of Vice President for Nursing at the Northeast Georgia Health System and
- 23 serves as the Executive Director of Government Affairs; and
- 24 WHEREAS, while working for the Northeast Georgia Health System, Deb was appointed
- 25 by Governor Perdue to the Committee on Public Health, and later, Governor Deal appointed
- 26 her to the Georgia Board of Nursing, the Georgia Hospital Medicaid Financial Program
- 27 Advisory Committee, and numerous other state committees; and
- 28 WHEREAS, Deb focuses on giving back to her community and currently serves as Mistress
- 29 of Ceremony for the Masters in the Art of Nursing program and is a member of the Brenau
- 30 Professional Advisory Board, the University of North Georgia Professional Sciences
- 31 Advisory Board, the Emory Doctorate Nurse Practitioner Board, the Legislative Taskforce
- 32 of the Georgia Hospital Association, Georgia Alliance of Community Hospitals, Safety Net
- 33 Coalition of Hospitals, and the Georgia Chamber; and
- 34 WHEREAS, she is also an accomplished writer and author, having published numerous
- 35 professional journals and coauthored several textbooks; and
- 36 WHEREAS, Deb's significant organizational and leadership talents, her remarkable patience
- and diplomacy, her keen sense of vision, and her sensitivity to the needs of the citizens of
- 38 this state have earned her the respect and admiration of her colleagues and associates; and
- 39 WHEREAS, Deb has served with honor and distinction with the Northeast Georgia Health
- 40 System, and her vision and unyielding commitment to health care have set the standard for
- 41 public service; and
- WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this
- 43 remarkable and distinguished Georgian be appropriately recognized.
