- 15 WHEREAS, Boyd has served as Chairman of the Georgia Environmental Finance Authority
- since 2015 and has served on its board since being appointed by Governor Perdue and
- 17 reappointed by Governor Deal; and
- 18 WHEREAS, this outstanding Georgian has served on the governing board of the
- 19 Metropolitan North Georgia Water Planning District since 2003, has served as Chairman
- 20 since 2011, and has been recognized numerous times as an authority on water issues,
- 21 bringing national recognition to the Water District for its conservation and public outreach
