A RESOLUTION

- 1 Creating the House Study Committee on School Counseling and the Role of School
- 2 Counselors; and for other purposes.
- 3 WHEREAS, our schools are experiencing an increasing number of students diagnosed and
- 4 undiagnosed with mental illness, which often results in student suicidal ideations, suicidal
- 5 completions, dropping out of school, social withdrawal, underachievement, absenteeism, or
- 6 in some instances, acts of school violence; and
- 7 WHEREAS, many of our students are experiencing increasing social/emotional issues that
- 8 manifest in drug use, misuse, and abuse; bullying; and other unhealthy life choices; and
- 9 WHEREAS, students in elementary and middle schools without a school counselor often
- 10 lack the foundation in college and career awareness and exploration which may result in the
- 11 failure to enroll in the necessary high school courses that will prepare them for the future;
- 12 and
- WHEREAS, our school leader programs do not include training on the role of the school
- 14 counselor; and
- 15 WHEREAS, our state does not have a standard performance evaluation specific to school
- 16 counseling; and
- 17 WHEREAS, school counselors lack access to professional learning specific to school
- 18 counseling; and
- 19 WHEREAS, school counselor caseloads, based on current funding, often prevent equitable
- 20 student access to school counseling services; and

21 WHEREAS, school counselor responsibilities are often not aligned with the required school

- 22 counselor master's level training; and
- WHEREAS, school counselors can play a critical role in helping to establish and maintain
- a positive school climate; and
- 25 WHEREAS, comprehensive school counseling programs can have a positive impact on the
- 26 academic, career, and social/emotional development of all students; and
- 27 WHEREAS, efforts need to be undertaken to ensure that all schools implement
- 28 comprehensive school counseling programs; and
- 29 WHEREAS, efforts need to be undertaken to ensure that all students have access to a school
- 30 counselor.
- 31 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES:
- 32 (1) **Creation of House study committee.** There is created the House Study Committee
- on School Counseling and the Role of School Counselors.
- 34 (2) **Members and officers.** The committee shall be composed of six members of the
- 35 House of Representatives to be appointed by the Speaker of the House of
- Representatives. The Speaker shall designate one of such members as chairperson.
- 37 (3) **Powers and duties.** The committee shall undertake a study of the conditions, needs,
- issues, and problems mentioned above or related thereto and recommend any action or
- legislation which the committee deems necessary or appropriate.
- 40 (4) **Meetings.** The chairperson shall call all meetings of the committee. The committee
- 41 may conduct such meetings at such places and at such times as it may deem necessary or
- 42 convenient to enable it to exercise fully and effectively its powers, perform its duties, and
- accomplish the objectives and purposes of this resolution.
- 44 (5) **Allowances and funding.** The legislative members of the committee shall receive
- 45 the allowances provided for in Code Section 28-1-8 of the Official Code of Georgia
- Annotated. The allowances authorized by this resolution shall not be received by any
- 47 member of the committee for more than five days unless additional days are authorized.
- Funds necessary to carry out the provisions of this resolution shall come from funds
- appropriated to the House of Representatives.
- 50 (6) **Report.**
- 51 (A) In the event the committee adopts any specific findings or recommendations that
- 52 include suggestions for proposed legislation, the chairperson shall file a report of the

53 same prior to the date of abolishment specified in this resolution, subject to 54 subparagraph (C) of this paragraph. 55 (B) In the event the committee adopts a report that does not include suggestions for proposed legislation, the chairperson shall file the report, subject to subparagraph (C) 56 57 of this paragraph. (C) No report shall be filed unless the same has been approved prior to the date of 58 59 abolishment specified in this resolution by majority vote of a quorum of the committee. A report so approved shall be signed by the chairperson of the committee and filed with 60 the Clerk of the House of Representatives. 61 (D) In the absence of an approved report, the chairperson may file with the Clerk of the 62 63

House of Representatives copies of the minutes of the meetings of the committee in lieu thereof.

(7) **Abolishment.** The committee shall stand abolished on December 1, 2015.
