A RESOLUTION

- 1 Recognizing and commending Easterseals and all its Georgia chapters; and for other
- 2 purposes.
- 3 WHEREAS, Easterseals is one of the nation's largest nonprofit healthcare providers serving
- 4 more than 1.5 million annually across the country; and
- 5 WHEREAS, Easterseals began in 1919 through the founding of the National Society for
- 6 Crippled Children, which gave way to the birth of the "seals" in 1934 and its lily logo,
- 7 symbolizing spring; and
- 8 WHEREAS, Easterseals offers several services including early intervention (EPSDT),
- 9 inclusive childcare, medical rehabilitation and autism services for children and their families,
- 10 job training and coaching, employment placement and transportation for adults with
- disabilities, adult day services and employment opportunities, mental health and recovery
- 12 programming, assistive technology, recreational activities, care giving support, and respite;

14 WHEREAS, since its beginnings, Easterseals has grown and now has five chapter locations

- 15 in Georgia serving multi-county areas around Albany, Atlanta, Augusta, Columbus, and
- 16 Dublin; and
- 17 WHEREAS, Easterseals has long advocated for individuals with disabilities and was a
- 18 leading advocate for the passage of the Americans with Disabilities Act; locally, Easterseals
- 19 has worked on several pieces of legislation addressing mental health, child welfare, provider
- 20 reimbursement, and much more; and
- 21 WHEREAS, Easterseals and its Georgia chapters also collaborate to serve children who are
- 22 ineligible for the Katie Beckett Waiver, and Easterseals continues to serve as the fiscal agent
- 23 for an appropriation that created the Champions for Children program, helping those
- 24 medically fragile children who do not meet the waiver to access services and treatment; and
- 25 WHEREAS, it is abundantly fitting and proper that Easterseals Georgia locations as well as
- 26 their staff and volunteers be recognized for their accomplishments in serving Georgians with
- 27 disabilities.
- 28 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
- 29 the members of this body extend a warm greeting to Easterseals Georgia as well as its staff
- 30 and volunteers and the persons that the organization serves and convey their heartiest
