## A RESOLUTION

1 Recognizing and commending Together Georgia; and for other purposes.

2 WHEREAS, Together Georgia is a nonprofit alliance of children and family service3 providers; and

WHEREAS, Together Georgia serves as a voice for Georgia's children and their families;
advocates on behalf of its members; provides education and training to its members; and
elevates its members' work in their communities; and

7 WHEREAS, Together Georgia serves as a leader in Georgia's child and family welfare8 policy-making; and

9 WHEREAS, with an extensive number of members located throughout the state, Together
10 Georgia's members provide services and care to Georgia's most vulnerable children and their
11 families; and

WHEREAS, Together Georgia's network provides family preservation and support programs,
education programs, psychiatric residential treatment facilities, adoption and maternity
homes, family foster care, therapeutic foster care, community group homes, emergency care,

15 outdoor therapeutic programs, and independent living and after care programs for children

16 and youth aging out of the state's system; and

WHEREAS, Together Georgia consistently participates and collaborates with state agencies
and other nonprofits to improve services and programs for children, youth, and their families;
and

WHEREAS, Together Georgia routinely addresses providers' concerns involving Georgia's Medicaid system, including working with care management organizations; collaborating with the Department of Education to mitigate concerns about funding for educational instruction to children entrusted in their members' care; and addressing the Department of Human Services' requirements for licensure of members' facilities to operate and serve Georgia's most vulnerable children; and

WHEREAS, Together Georgia seeks to provide to its members research and information on
 current issues, best practices, and trends in child welfare, administrative office solutions and
 purchasing resources, and professional development; and

WHEREAS, Together Georgia annually hosts the Georgia Children and Families Conference, a forum that helps provider partners and those working in child welfare by providing information about trends impacting the provision of services to children and families; and

WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this
distinguished organization, including its staff, its partner entities, and its volunteers, be
appropriately recognized for their dedication and work to better the lives of Georgia children,
youth, and their families.
