## **A RESOLUTION**

- 1 Recognizing and commending the Georgia Academy of Audiology; and for other purposes.
- 2 WHEREAS, about 60.7 million Americans aged 12 and older struggle with hearing loss; and
- 3 WHEREAS, hearing loss is on the rise in the United States and is expected to double by the
- 4 year 2060; and
- 5 WHEREAS, Georgia is not immune to the aforementioned national statistics, and many
- 6 Georgians are impacted by hearing loss and balance disorders; and
- 7 WHEREAS, in our state, audiologists are Georgia-licensed professionals holding Doctor of
- 8 Audiology (AuD) degrees or other doctoral degrees from accredited universities with
- 9 specialized training programs in the identification, assessment, and treatment of hearing and
- 10 balance disorders; and
- WHEREAS, audiologists work collaboratively to provide evaluations and treatment options
- 12 for hearing losses and balance disorders as well as educate about prevention efforts in private
- 13 practices, hospitals, clinics, physician offices, universities, pre-k through 12 schools, and
- 14 government and military practices; and

- 23 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this
- 24 organization and its members be appropriately recognized for the healthcare services
- 25 provided to Georgians, including their leadership on healthcare policy.
- 26 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
- 27 the members of this body recognize and commend the Georgia Academy of Audiology for
- 28 its years of efficient, effective, unselfish, and dedicated public service to the citizens of this
