## A BILL TO BE ENTITLED AN ACT

- 1 To amend Article 1 of Chapter 3 of Title 35 of the Official Code of Georgia Annotated,
- 2 relating to general provisions concerning the Georgia Bureau of Investigation, so as to
- 3 provide for independent and concurrent jurisdiction by the Georgia Bureau of Investigation
- 4 in cases involving the identification, investigation, arrest, and prosecution of an individual

- 6 chemical, and nuclear terrorism; to provide for a short title; to provide for related matters;

- 10 This Act shall be known and may be cited as the "Georgia Fights Terrorism Act."

- 14 Code Section 35-3-8.1, relating to power of bureau to assist other law enforcement agencies,

17 (a) Upon request of the governing authority or chief law enforcement officer of any 18 municipality, the sheriff of any county, the chief of the county police force of any county 19 having a population of more than 100,000 according to the United States decennial census 20 of 1970 or any future such census, the a judge of the superior court of any county of this 21 state, or the Governor, the director, in unusual circumstances, may, and in the case of a 22 request by the Governor, shall, direct the bureau to render assistance in any criminal case, 23 in the prevention or detection of violations of law, or in the detection or apprehension of 24 persons violating the criminal laws of this state, any other state, or the United States. 25 (b) The bureau shall be authorized to work independently, work concurrently with other 26 law enforcement agencies, and request the assistance of other law enforcement agencies 27 when, in the sole discretion of the director, such independent work, concurrent work, or 28 request for assistance would not compromise the successful completion of cases involving 29 the identification, investigation, arrest, and prosecution of an individual or groups of 30 individuals for violation of laws concerning domestic, cyber, biological, chemical, and 31 nuclear terrorism."

32 SECTION 3.

This Act shall become effective upon its approval by the Governor or upon its becoming law without such approval

36 All laws and parts of laws in conflict with this Act are repealed.
