The Senate Committee on Health and Human Services offered the following substitute to SB 116:

## A BILL TO BE ENTITLED AN ACT

- 1 To amend Article 1 of Chapter 5 of Title 49 of the Official Code of Georgia Annotated,
- 2 relating to children and youth services, so as to provide for registration of maternity
- 3 supportive housing residences to provide housing for pregnant women; to define a term; to
- 4 provide for requirements; to prohibit additional rules and regulations; to prohibit constraints

- 6 matters; to provide a short title; to repeal conflicting laws; and for other purposes.

## 7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

9 This Act shall be known and may be cited as "The Maternity Supportive Housing Act."

SECTION 2.

- 11 Article 1 of Chapter 5 of Title 49 of the Official Code of Georgia Annotated, relating to
- 12 children and youth services, is amended in Code Section 49-5-3, relating to definitions, by
- 13 adding a new paragraph to read as follows:
- 14 "(13.1) 'Maternity supportive housing residence' means a residential home that houses
- on behalf of a nonprofit organization up to six pregnant women aged 18 years or older

and their minor children at any one time during the woman's pregnancy and up to 18
months after childbirth; provided, however, that no services other than housing shall be
provided. This term shall not include the residential home of a relative in which a woman

19 receives maternity care or a general or special hospital."

SECTION 3.

- 21 Said article is further amended by adding a new Code section to read as follows:
- 22 "49-5-25.
- 23 (a)(1) On and after July 1, 2021, all maternity supportive housing residences shall
- register in accordance with this Code section by submitting an application to the
- 25 <u>department upon forms furnished by the department.</u> The form furnished by the
- department shall require the name, address, and telephone number of the maternity
- 27 <u>supportive housing residence and emergency contact information.</u>
- 28 (2) A registrant shall be required to pay an annual registration fee of \$250.00 to the
- department.
- 30 (3) The department shall issue a registration certificate, valid for one year, to a maternity
- 31 <u>supportive housing residence upon receipt of an application for registration, payment of</u>
- 32 the registration fee, and notarized attestation by the applicant that the maternity
- 33 <u>supportive housing residence:</u>
- 34 (A) Has written policies and procedures for admission, intake, and record keeping;
- 35 (B) Is in compliance with applicable residential building codes; and
- 36 (C) Has property insurance coverage on the residence.
- 37 (b) The department shall not have the authority to implement rules and regulations for the
- 38 registration of maternity supportive housing residences but shall have the authority to
- 39 maintain any records submitted by a residence pursuant to paragraph (3) of subsection (a)
- 40 of this Code section.

41 (c) No county, municipality, or consolidated government shall, by rule or ordinance,

- 42 constrain the establishment or operation of maternity supportive housing residences or
- 43 place occupancy requirements on such residences that would not apply to a single family
- 44 <u>living in the residence.</u>
- 45 (d) Nothing in this Code section shall be construed to require a maternity home to register
- 46 with the department pursuant to this Code section or for a maternity supportive housing
- 47 residence to obtain a license or permit as a maternity home or to meet the requirements of
- 48 <u>a maternity home.</u>"
