A BILL TO BE ENTITLED AN ACT

- 1 To amend Code Section 33-7-6 of the Official Code of Georgia Annotated, relating to
- 2 property insurance, contract requirements, rules and regulations, and exemptions, so as to
- 3 include contracts, agreements, and instruments for the repair of certain wear and tear of a
- 4 motor vehicle to include rips, burns, tears, holes, and punctures to interior fabric or carpet,
- 5 cosmetic repair to aluminum or painted wheels, and exterior reconditioning of foggy or
- 6 yellowed headlights within the definition of property insurance in a manner similar to vehicle
- 7 service agreements or extended warranty agreements; to provide for related matters; to repeal
- 8 conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

10 **SECTION 1.** Code Section 33-7-6 of the Official Code of Georgia Annotated, relating to property 11 12 insurance, contract requirements, rules and regulations, and exemptions, is amended by 13 revising paragraph (1) of subsection (b) as follows: 14 "(1) Any contract, agreement, or instrument whereby a person assumes the risk of and 15 the expense or portion thereof for: 16 (A) The the mechanical breakdown or mechanical failure of a motor vehicle; or for the 17 (B) The repair of certain reasonable motor vehicle wear and tear sustained in ordinary 18 use, such as: 19 (i) The removal of dents, dings, or creases in a motor vehicle without affecting the 20 existing paint finish using paintless dent repair techniques; or the 21 (ii) The removal of small windshield chips and cracks without replacement of the 22 entire windshield;

surfaces, including, but not limited to, bumpers;

(iii) The repair of rips, burns, tears, holes, and punctures to interior fabric or carpet;

(iv) Cosmetic repair of minor scuffs, scratches, scrapes, or rash on exterior plastic

26	(v) Cosmetic repair to aluminum or painted wheels when the normal appearance of
27	the wheel is altered with minor curb scuffs, scratches, scrapes, or rash; or
28	(vi) Exterior reconditioning of foggy or yellowed headlights to restore clarity and
29	<u>luster</u> ,
30	and shall include those agreements commonly known as vehicle service agreements or
31	extended warranty agreements, if made by a person other than the motor vehicle
32	manufacturer in exchange for a separately stated charge or the cost of the contract or
33	contracts is included on a nonidentifiable basis in the cost of a motor vehicle sold in
34	conjunction therewith, except that this provision shall not apply to an agreement underwritten
35	by an insurer licensed to transact insurance in this state, either directly or through a
36	reinsurance contract or, without regard to the requirement that the insurance cannot be
37	obtained from an insurer authorized to do business in this state as required by Code
38	Section 33-5-21, to an agreement underwritten by a surplus lines insurer which has not been
39	rejected by the Commissioner for such purpose;"

40 SECTION 2.

41 All laws and parts of laws in conflict with this Act are repealed.
