A BILL TO BE ENTITLED AN ACT

- 1 To amend Article 1 of Chapter 3 of Title 32 of the Official Code of Georgia Annotated,
- 2 relating to general provisions relative to acquisition of property for transportation purposes,
- 3 so as to provide for attorney's fees and expenses of trial in appeals to condemnation
- 4 compensation award amounts; to provide for related matters; to repeal conflicting laws; and
- 5 for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

- 8 Article 1 of Chapter 3 of Title 32 of the Official Code of Georgia Annotated, relating to
- 9 general provisions relative to acquisition of property for transportation purposes, is amended
- 10 by revising Code Section 32-3-19, relating to jury's award in appeals to condemnation
- 11 compensation, as follows:
- 12 "32-3-19.

- 13 (a) The verdict of the jury shall have respect to the lands described in the declaration of
- taking as set forth in Code Section 32-3-6, or such interest therein as may be described in
- said declaration, or to any separate claim against the property or interest therein as may be
- ordered and may be molded under the direction of the court so as to do complete justice
- and avoid confusion of interest. The court shall give such direction as to the disposition
- of the fund as shall be proper according to the rights of the several respondents.
- 19 (b) After the verdict of the jury, the court shall, in instances where no motion for new trial
- or notice of appeal is filed within the time provided for by law or where such verdict has
- been affirmed by a proper appellate court and the remittitur from such court has been made
- the judgment of the superior court, enter judgment in favor of the condemnee and against
- 23 the condemnor in the amount of such verdict, together with the accrued court costs,
- 24 reasonable attorney's fees, and expenses of litigation, including investigation expenses,
- 25 expert witness fees, and other expenses which relate to the preparation for trial. which
- 26 Such judgment shall be immediately credited with the sum of money deposited by the
- 27 condemnor with the declaration of taking and which shall bear interest as provided in

subsection (c) of this Code section; and, upon the failure or refusal of the condemnor immediately to deposit such increase in such sum into the registry of the court, as well as the accrued court costs <u>and expenses provided for in this subsection</u>, it shall be the duty of said clerk to issue execution therefor.

(c) After just and adequate compensation has been ascertained and established by judgment, the judgment shall include, as part of the just and adequate compensation awarded, interest from the date of taking to the date of payment pursuant to final judgment at the rate of 7 percent per annum on the amount awarded by final judgment as the value of the property as of the date of taking; but interest shall not be allowed on so much thereof as shall have been paid into the court and was subject to withdrawal by the condemnee without the requirement of posting a bond as required by Code Section 32-3-15. However, if the condemnee posted the bond and withdrew the additional deposit made after the special master's award and is later awarded a sum greater than the original deposit but less than the special master's award, the condemnee shall not be entitled to interest on this additional deposit for the time he or she had use of the money; but he or she shall be entitled to receive the percentage of the reasonable cost of the bond that the sum awarded over the original deposit bears to the sum of the special master's award over the original deposit. If the condemnee is later awarded a sum that exceeds the special master's award and he <u>or she</u> has posted bond and withdrawn the additional deposit, he <u>or she</u> shall not be entitled to interest on this additional deposit for the time he or she had use of the money, but he <u>or she</u> shall be entitled to the reasonable cost of the bond.

- 49 (d) No sum so paid into the court shall be charged with commissions or poundage.
- 50 (e) In any event, the case shall be transferred, under the conditions set out in this Code 51 section, to the closed docket. Nothing in this Code section shall be construed as in any way 52 affecting the title acquired by the condemnor by virtue of the declaration of taking as

provided for in Code Section 32-3-7."
