A BILL TO BE ENTITLED AN ACT

- 1 To amend Chapter 3 of Title 47 of the Official Code of Georgia Annotated, relating to the
- 2 Teachers Retirement System of Georgia, so as to provide that a retired member who elected
- 3 an optional retirement allowance that included one or more named beneficiaries shall be
- 4 eligible to change any of such named beneficiaries under certain conditions and limitations;
- 5 to provide for related matters; to provide conditions for an effective date and automatic
- 6 repeal; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 Chapter 3 of Title 47 of the Official Code of Georgia Annotated, relating to the Teachers
- 10 Retirement System of Georgia, is amended in Code Section 47-3-121, relating to optional
- 11 retirement allowances, election of such options, revocation of election, and effect of divorce,
- 12 by adding a new subsection to read as follows:
- 13 "(m)(1) On and after July 1, 2022, any retired member who elected an option pursuant
- to this Code section and nominated one or more other persons to receive any benefit
- amount shall have the option to elect to change one or more of such named beneficiaries
- at any time, provided that such retired member's retirement allowance or the amount

17 allowed to any named beneficiaries shall be recalculated so as to ensure that the

- combined cost to the retirement system with respect to any election pursuant to this
- 19 <u>subsection shall be the actuarial equivalent of the retirement allowance that was in effect</u>
- 20 <u>immediately prior to the effective date of such election pursuant to this subsection.</u>
- 21 (2) Any election made pursuant to this subsection shall become effective on the first day
- of the second month following the month in which such election is made. In no event
- shall any election, payment, adjustment, or application of this subsection be made
- 24 <u>effective retroactively.</u>
- 25 (3) A member shall not be permitted to make an election pursuant to this subsection
- 26 more than once every three years.
- 27 (4) The provisions of this subsection shall have no bearing on the provisions of
- subsection (f), (k), or (1) of this Code section."
- SECTION 2.
- 30 This Act shall become effective on July 1, 2022, only if it is determined to have been
- 31 concurrently funded as provided in Chapter 20 of Title 47 of the Official Code of Georgia
- 32 Annotated, the "Public Retirement Systems Standards Law;" otherwise, this Act shall not
- 33 become effective and shall be automatically repealed in its entirety on July 1, 2022, as
- 34 required by subsection (a) of Code Section 47-20-50.
- 35 SECTION 3.
- 36 All laws and parts of laws in conflict with this Act are repealed.
