## A BILL TO BE ENTITLED AN ACT

- 1 To amend Part 1 of Article 3 of Chapter 12 of Title 16 of the Official Code of Georgia
- 2 Annotated, relating to general provisions regarding obscenity and related offenses, so as to
- 3 prohibit the possession, sale, loan, give away, distribution, transmission, exhibition, showing,
- 4 or manufacture of childlike sex dolls; to provide for a definition; to provide for penalties; to
- 5 provide for related matters; to repeal conflicting laws; and for other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

- 8 Part 1 of Article 3 of Chapter 12 of Title 16 of the Official Code of Georgia Annotated,
- 9 relating to general provisions regarding obscenity and related offenses, is amended by
- 10 revising Code Section 16-12-84, which was previously reserved, as follows:

- 12 (a) As used in this Code section, the term 'childlike sex doll' shall mean any doll,
- mannequin, robot, or similar item that has the features of or has features that resemble
- 14 those of a human being under the age of 18 and is designed or intended for the purpose of
- 15 <u>sexual stimulation or gratification</u>. Such term shall not include anatomically correct dolls
- or mannequins that are designed for educational purposes or for use in law enforcement or
- 17 <u>treatment and evaluation of sexual abuse or sex crimes.</u>
- 18 (b) It shall be illegal to knowingly have possession, custody, or control of a childlike sex
- doll in this state. A person convicted of the possession of a childlike sex doll shall be
- 20 guilty, on the first offense, of a misdemeanor of a high and aggravated nature and, on the
- 21 <u>second and subsequent offenses, shall be guilty of a felony and shall be punished by</u>
- 22 <u>imprisonment for not less than one nor more than five years, a fine not to exceed</u>
- 23 \$10,000.00, or both.
- 24 (c) It shall be illegal in this state to knowingly:
- 25 (1) Sell, lend, give away, distribute, transmit, exhibit, show, or manufacture a childlike
- sex doll;

- 28 <u>manufacture a childlike sex doll;</u>
- 29 (3) Offer to sell, lend, give away, distribute, transmit, exhibit, show, or manufacture a
- 30 <u>childlike sex doll; or</u>
- 31 (4) Advertise in any manner a childlike sex doll.
- 32 A person convicted of a violation of this subsection shall be guilty of a felony and shall be
- 33 punished by imprisonment for not less than one nor more than ten years, a fine not to
- 34 exceed \$25,000.00, or both Reserved."

36 All laws and parts of laws in conflict with this Act are repealed.
