## A BILL TO BE ENTITLED AN ACT

1 To amend Chapter 5 of Title 21 of the Official Code of Georgia Annotated, relating to 2 government transparency and campaign finance, so as to prohibit foreign nationals from 3 contributing to candidates or campaign, independent, or political action committees; to 4 prohibit candidates and campaign, independent, and political action committees from 5 accepting contributions from foreign nationals; to provide for definitions; to require agents 6 of foreign principals to register with the State Ethics Commissioner; to provide for 7 registration requirements; to require agents of foreign principals to disclose to government 8 agencies and the General Assembly when such agents are advocating on behalf of a foreign 9 principal; to provide for related matters; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

## **SECTION 1.**

12 Chapter 5 of Title 21 of the Official Code of Georgia Annotated, relating to government13 transparency and campaign finance, is amended in Code Section 21-5-3, relating to14 definitions, by adding a new paragraph to read as follows:

120 to which each such foreign principal is supervised, directed, owned, controlled, financed, 121 or subsidized, in whole or in part, by any government of a foreign country or foreign 122 political party, or by any other foreign principal; 123 (5) The nature and amount of contributions, income, money, or thing of value, if any, 124 that the registrant has received within the preceding 60 days from each such foreign 125 principal, either as compensation or for disbursement or otherwise, and the form and time 126 of each such payment and from whom received; 127 (6) A detailed statement of every activity which the registrant is performing or is assuming or purporting or has agreed to perform for himself or herself or any other 128 129 person other than a foreign principal and which requires his registration hereunder; (7) The name, business, and residence addresses, and if an individual, the nationality, of 130 any person other than a foreign principal for whom the registrant is acting, assuming or 131 purporting to act or has agreed to act under such circumstances as require his or her 132 133 registration hereunder; 134 (8) The nature and amount of contributions, income, money, or thing of value, if any, 135 that the registrant has received during the preceding 60 days from each such person in connection with any of the activities referred to in paragraph (6) of this subsection; 136 (9) A detailed statement of the money and other things of value spent or disposed of by 137 the registrant during the preceding 60 days in furtherance of or in connection with 138 139 activities which require the registrant's registration hereunder and which have been undertaken by the registrant either as an agent of a foreign principal or for himself or 140 herself or any other person or in connection with any activities relating to the registrant 141 becoming an agent of such principal; 142 (10) A detailed statement of any contributions of money or other things of value made 143 by the registrant during the preceding 60 days to bring about the nomination or election 144 of a candidate for any office, to bring about the recall of a public officer holding elective 145 146 office, to oppose the recall of a public officer holding elective office, to bring about the

- 169 Whenever any agent of a foreign principal required to register under Code Section 21-5-77
- 170 appears before any elected official, agency, as such term is defined in Code Section
- 171 <u>50-14-1, officer, official, or employees of an agency, or a committee of General Assembly,</u>
- 172 to advocate, lobby, or testify for or in the interests of such foreign principal, such agent

- 173 shall, at the time of such appearance, affirmatively state that he or she is acting as an agent
- 174 of a foreign principal and disclose the identify of such foreign principal."
