A BILL TO BE ENTITLED AN ACT

- 1 To amend Article 1 of Chapter 9 of Title 34 of the Official Code of Georgia Annotated,
- 2 relating to general provisions of workers' compensation, so as to require the State Board of
- 3 Workers' Compensation to investigate and notify the Department of Administrative Services
- 4 when a peace officer is awarded workers' compensation benefits and suffered catastrophic
- 5 injury under certain circumstances; to provide for definitions; to amend Article 5 of Chapter
- 6 9 of Title 45 of the Official Code of Georgia Annotated, relating to law enforcement officers,
- 7 firemen, prison guards, and publicly employed emergency medical technicians, so as to
- 8 provide compensation to eligible peace officers from the State Indemnification Fund; to
- 9 provide for related matters; to provide for a short title; to repeal conflicting laws; and for
- 10 other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

12 SECTION 1.

13 This Act shall be known and may be cited as the "Daniel D. Podsiadly, Jr. Act."

14 **SECTION 2.**

15 Article 1 of Chapter 9 of Title 34 of the Official Code of Georgia Annotated, relating to general provisions of workers' compensation, is amended by adding a new Code section to

17 read as follows:

"34-9-26. 19 (a) As used in this Code section, the term 'eligible peace officer' means any individual who 20 is employed on a full-time or part-time basis by the state or any municipality, county, or 21 other political subdivision thereof; who is required by the terms of such employment, 22 whether by election or appointment, to maintain public order or to make arrests for all 23 criminal offenses; who is required by the terms of such employment to comply with the 24 requirements of the 'Georgia Peace Officer Standards and Training Act' contained in 25 Chapter 8 of Title 35; and who suffers catastrophic injury, as defined in subsection (g) of Code Section 34-9-200.1, in the line of duty while immediately engaged with a criminal 26 27 suspect or in the immediate pursuit thereof. 28 (b) In the event that the State Board of Workers' Compensation determines that an 29

employee suffered a catastrophic injury, the board shall investigate the circumstances of 30 such injury to determine if the employee was an eligible peace officer. Upon a 31 determination that such employee will be awarded workers' compensation and is an eligible 32 peace officer, the board shall notify and transfer a copy of such eligible peace officer's 33 claim file to the Department of Administrative Services and notify the eligible peace officer 34 of such transfer within ten days of such determination."

35 **SECTION 3.**

36 Article 5 of Chapter 9 of Title 45 of the Official Code of Georgia Annotated, relating to law enforcement officers, firemen, prison guards, and publicly employed emergency medical 38 technicians, is amended by revising Code Section 45-9-85, relating to payment of

39 indemnification for death or disability, procedure for making payments, and appeal, as 40 follows:

- 41 "45-9-85.
- 42 (a) As used in this Code section, the term:
- 43 (1) 'Nonroutine stressful or strenuous physical activity' means actions that are not
- declerical, administrative, or nonmanual in nature.
- 45 (2) 'Peace officer' means any individual who is employed on a full-time or part-time
- basis by the state or any municipality, county, or other political subdivision thereof; who
- is required by the terms of such employment, whether by election or appointment, to
- 48 maintain public order or to make arrests for all criminal offenses; who is required by the
- 49 terms of such employment to comply with the requirements of the 'Georgia Peace Officer
- 50 Standards and Training Act' contained in Chapter 8 of Title 35; and who suffers
- 51 catastrophic injury, as defined in subsection (g) of Code Section 34-9-200.1, in the line
- of duty while immediately engaged with a criminal suspect or in the immediate pursuit
- thereof. Such term is a different category of employee from 'law enforcement officer.'
- 54 (2)(3) 'Public safety officer' means a law enforcement officer, firefighter, emergency
- medical technician, emergency management rescue specialist, state highway employee,
- or prison guard.
- 57 (3)(4) 'Work related activity' means, while in the line of duty:
- 58 (A) Engaging in a situation involving nonroutine stressful or strenuous physical
- activity related to law enforcement, fire suppression, rescue, hazardous material
- response, emergency medical services, prison or jail security, disaster relief, or any
- other emergency response; or
- 62 (B) Participating in a training exercise involving nonroutine stressful or strenuous
- 63 physical activity.
- 64 (b) Indemnification shall be paid under this article as follows:

65 (1) In the case of a partial permanent disability suffered in the line of duty by a public 66 safety officer, the eligible disabled person may elect payment of \$35,000.00 paid in equal

- 67 monthly installments for five years or a lump sum of such amount reduced to its present
- value upon the basis of interest calculated at the rate of 6 percent per annum;
- 69 (2) In the case of a total permanent disability suffered in the line of duty by a public
- safety officer, the injured person may elect to receive a payment of \$75,000.00 paid in
- equal monthly installments for five years or a lump sum of such amount reduced to its
- 72 present value upon the basis of interest calculated at the rate of 6 percent per annum;
- 73 (3)(A) In the case of death suffered in the line of duty by a public safety officer,
- payment shall be made to:
- 75 (i) The surviving unremarried spouse;
- 76 (ii) The surviving children who are under the age of 19 or, if a student enrolled in an
- institution of postsecondary education at the time of such death, under the age of 24;
- 78 or
- 79 (iii) Individuals not otherwise provided for under this subparagraph who are the
- dependents of the spouse or deceased person as shown in the spouse's or deceased
- person's most recent tax return.
- 82 (B) In the case of organic brain damage suffered in the line of duty by a public safety
- officer, payment shall be made to the legal guardian of the organically brain damaged
- 84 person.
- 85 (C) The surviving unremarried spouse, dependents, or the legal guardian may elect to
- receive payment in a lump sum payment of \$150,000.00 paid in equal monthly
- installments for five years or a lump sum of such amount reduced to its present value
- upon the basis of interest calculated at the rate of 6 percent per annum; or
- 89 (4) In the case of an employee who has been awarded workers' compensation benefits
- 90 by the State Board of Workers' Compensation and determined to be an eligible peace
- 91 officer pursuant to Code Section 34-9-26, such peace officer shall be paid the difference

between the workers' compensation, disability, or other compensation benefits paid or to

- be paid by such peace officer's employer and such peace officer's regular compensation
- 94 <u>as a peace officer;</u>
- 95 (5) Any person who receives payment in accordance with paragraph (4) of this
- subsection shall not be eligible to receive payment in accordance with paragraph (1) or
- paragraph (2) of this subsection; or
- 98 (4)(6) A heart attack, stroke, or vascular rupture suffered by a public safety officer shall
- be presumed to qualify such public safety officer under this subsection if the heart attack,
- stroke, or vascular rupture:
- 101 (A) Commenced:
- (i) While such public safety officer was performing work related activity;
- 103 (ii) While such public safety officer was on duty after performing work related activity; or
- 105 (iii) Not later than 24 hours after performing work related activity; and
- (B) Directly or proximately resulted in the death or partial or permanent disability of
- the public safety officer, unless competent medical evidence established that the heart
- attack, stroke, or vascular rupture was not related to the work related activity or was
- directly or proximately caused by something other than the mere presence of
- cardiovascular disease risk factors.
- 111 (c) After the department, or the commissioner or his or her designee upon review of a
- denial by the department, determines that a public safety officer has suffered a total
- permanent disability, a partial permanent disability, organic brain damage, or death in the
- line of duty, the department shall be authorized to make the appropriate payments as
- provided in subsection (b) of this Code section.
- 116 (d) If the department denies a claim, any person seeking benefits pursuant to this part may
- appeal the department's decision to the commissioner or his or her designee. Any such
- appeal shall be filed with the commissioner or his or her designee within 60 days of receipt

of the department's decision and shall identify the errors in the department's decision.

- 120 Appeals shall be considered by the commissioner or his or her designee as provided in
- 121 Code Section 45-9-84."
