## A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act providing for the election of the Board of Education of Columbia County,
- 2 approved March 21, 1968 (Ga. L. 1968, p. 2708), as amended, particularly by an Act
- 3 approved March 5, 2012 (Ga. L. 2012, p. 3991), so as to change the description of the
- 4 education districts; to provide for definitions and inclusions; to provide for the continuation
- 5 in office of current members; to provide for effective dates; to provide for related matters;
- 6 to repeal conflicting laws; and for other purposes.

## 7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act providing for the election of the Board of Education of Columbia County, approved
- 10 March 21, 1968 (Ga. L. 1968, p. 2708), as amended, particularly by an Act approved
- 11 March 5, 2012 (Ga. L. 2012, p. 3991), is amended by revising Section 1 as follows:
- 12 "SECTION 1.
- 13 (a) The Board of Education of Columbia County shall be composed of five members to
- be elected as provided in this Act. For the purposes of electing members of the board of
- education, Columbia County is divided into four education districts. The four education

districts shall be and correspond to those four numbered districts described in Appendix

- 17 A attached to and made a part of this Act and further identified as 'User: Columbia Co. Plan
- Name: columbiaccsb-2022 Plan Type: Local'. The chairperson of the board shall be
- 19 elected by the electors of the entire county.
- 20 (b)(1) For the purposes of such plan:
- 21 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
- provided in the report of the Bureau of the Census for the United States decennial
- census of 2020 for the State of Georgia. The separate numeric designations in a district
- description which are underneath a VTD heading shall mean and describe individual
- 25 Blocks within a VTD as provided in the report of the Bureau of the Census for the
- United States decennial census of 2020 for the State of Georgia; and
- 27 (B) Except as otherwise provided in the description of any district, whenever the
- description of any district refers to a named city, it shall mean the geographical
- boundaries of that city as shown on the census maps for the United States decennial
- census of 2020 for the State of Georgia.
- 31 (2) Any part of the Columbia County School District which is not included in any district
- described in subsection (b) of this section shall be included within that district contiguous
- 33 to such part which contains the least population according to the United States decennial
- census of 2020 for the State of Georgia.
- 35 (3) Any part of the Columbia County School District which is described in subsection (b)
- of this section as being included in a particular district shall nevertheless not be included
- within such district if such part is not contiguous to such district. Such noncontiguous
- part shall instead be included within that district contiguous to such part which contains
- 39 the least population according to the United States decennial census of 2020 for the State
- 40 of Georgia."

41 SECTION 2.

- 42 (a) Those members of the Board of Education of Columbia County who are serving as such
- 43 on the effective date of this Act and any person selected to fill a vacancy in any such office
- 44 shall continue to serve as such members until the regular expiration of their respective terms
- 45 of office and upon the election and qualification of their respective successors.
- 46 (b) Districts 1, 2, 3, and 4, as they exist immediately prior to the effective date of this Act,
- 47 shall continue to be designated as Districts 1, 2, 3, and 4, respectively, but as newly described
- 48 under this Act, and on and after the effective date of this Act, such members of the board
- 49 serving from those former districts shall be deemed to be serving from and representing their
- 50 respective districts as newly described under this Act.

51 SECTION 3.

- 52 The provisions of this Act necessary to conduct elections for the members of the Board of
- 53 Education of Columbia County in 2022 shall become effective upon the approval of this Act
- 54 by the Governor or upon its becoming law without such approval. The remaining provisions
- 55 of this Act shall become effective on January 1, 2023.

SECTION 4.

57 All laws and parts of laws in conflict with this Act are repealed.
