AS PASSED SENATE

A BILL TO BE ENTITLED

AN ACT

1 To amend an Act providing for a seven-member Board of Education of McDuffie County,
2 approved March 27, 1972 (Ga. L. 1972, p. 2538), as amended, particularly by an Act
3 approved April 18, 2013 (Ga. L. 2013, p. 3526), so as to change the description of the
4 education districts; to provide for definitions and inclusions; to provide for continuation in
5 office of current members; to provide for related matters; to provide for effective dates; to
6 repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act providing for a seven-member Board of Education of McDuffie County, approved
10 March 27, 1972 (Ga. L. 1972, p. 2538), as amended, particularly by an Act approved
11 April 18, 2013 (Ga. L. 2013, p. 3526), is amended by revising Section 1 as follows:

12 "SECTION 1.

13 (a) The Board of Education of McDuffie County shall be composed of seven members to
14 be elected in this Act. For the purpose of electing members of the board of education, the
15 McDuffie County School District shall be divided into seven education districts. Districts

16 1 and 2 shall be and correspond to those two numbered districts described in Appendix A
17 attached to and made a part of this Act and further identified as 'User: McDuffie CC Plan
18 Name: McDuffieCC-2022 Plan Type: Local'. Districts 3 through 7 shall be and correspond
19 to those five numbered districts described in Appendix B attached to and made a part of
20 this Act and further identified as 'User: McDuffie SB Plan Name: McDuffieSB-2022 Plan
21 Type: Local'.

22 (b)(1) For the purposes of such plan:

23 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
24 provided in the report of the Bureau of the Census for the United States decennial
25 census of 2020 for the State of Georgia. The separate numeric designations in a district
26 description which are underneath a VTD heading shall mean and describe individual
27 Blocks within a VTD as provided in the report of the Bureau of the Census for the
28 United States decennial census of 2020 for the State of Georgia; and

29 (B) Except as otherwise provided in the description of any district, whenever the
30 description of any district refers to a named city, it shall mean the geographical
31 boundaries of that city as shown on the census maps for the United States decennial
32 census of 2020 for the State of Georgia.

33 (2)(A) Any part of the McDuffie County School District which is not included in
34 Education District 1 or 2 as described in Appendix A shall be included within that
35 district contiguous to such part which contains the least population according to the
36 United States decennial census of 2020 for the State of Georgia.

37 (B) Any part of the McDuffie County School District which is described in
38 Appendix A as being included in a particular district shall nevertheless not be included
39 within such district if such part is not contiguous to such district. Such noncontiguous
40 part shall instead be included within that Education District 1 or 2 that is contiguous to
41 such part which contains the least population according to the United States decennial
42 census of 2020 for the State of Georgia.

43 (3)(A) Any part of the McDuffie County School District which is not included in
44 District 3, 4, 5, 6, or 7 as described in Appendix B shall be included within that district
45 contiguous to such part which contains the least population according to the United
46 States decennial census of 2020 for the State of Georgia.

47 (B) Any part of the McDuffie County School District which is described in Appendix
48 B as being included in Education District 3, 4, 5, 6, or 7 shall nevertheless not be
49 included within such district if such part is not contiguous to such district. Such
50 noncontiguous part shall instead be included within that District 3, 4, 5, 6, or 7 that is
51 contiguous to such part which contains the least population according to the United
52 States decennial census of 2020 for the State of Georgia."

53

SECTION 2.

54 (a) Those members of the Board of Education of McDuffie County who are serving as such
55 on the effective date of this Act and any person selected to fill a vacancy in any such office
56 shall continue to serve as such members until the regular expiration of their respective terms
57 of office and upon the election and qualification of their respective successors.

58 (b) Districts 1, 2, 3, 4, 5, 6, and 7, as they exist immediately prior to the effective date of this
59 Act, shall continue to be designated as Districts 1, 2, 3, 4, 5, 6, and 7, respectively, but as
60 newly described under this Act, and on and after the effective date of this Act, such members
61 of the board serving from those former districts shall be deemed to be serving from and
62 representing their respective districts as newly described under this Act.

63

SECTION 3.

64 The provisions of this Act necessary to conduct elections for the members of the Board of
65 Education of McDuffie County in 2022 shall become effective upon the approval of this Act
66 by the Governor or upon its becoming law without such approval. The remaining provisions
67 of this Act shall become effective on January 1, 2023.

SECTION 4.

69 All laws and parts of laws in conflict with this Act are repealed.
