A BILL TO BE ENTITLED AN ACT

- 1 To amend Article 6 of Chapter 2 of Title 21 of the Official Code of Georgia Annotated,
- 2 relating to registration of voters, so as to provide that any person convicted of a felony
- 3 involving moral turpitude shall not register to, remain registered to, or vote and to enumerate
- 4 such felony offenses; to provide for a definition; to provide for related matters; to provide
- 5 for an effective date; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7	SECTION 1.
8	Article 6 of Chapter 2 of Title 21 of the Official Code of Georgia Annotated, relating to
9	registration of voters, is amended in Code Section 21-2-216, relating to qualifications of
10	electors generally, reregistration of electors purged from list, eligibility of nonresidents who
11	vote in presidential elections, retention of qualification for standing as elector, evidence of
12	citizenship, and check of convicted felons and deceased persons databases, by revising
13	subsection (b) as follows:
14	"(b)(1) As used in this subsection, the term 'felony involving moral turpitude' means the

121	has been convicted of a felony involving moral turpitude may register to, remain
122	registered to, or vote except upon completion of the sentence and no person who has been
123	judicially determined to be mentally incompetent may register to, remain registered to,
124	or vote unless the disability has been removed."
125	SECTION 2.
126	This Act shall become effective on January 1, 2021.

128 All laws and parts of laws in conflict with this Act are repealed.
