AS PASSED SENATE

**A BILL TO BE ENTITLED
AN ACT**

1 To amend an Act providing a new charter for the City of Buford, approved June 3, 2003
2 (Ga. L. 2003, p. 4622), so as to change the corporate limits of the city; to repeal conflicting
3 laws; and for other purposes.

4 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

5 **SECTION 1.**

6 An Act providing a new charter for the City of Buford, approved June 3, 2003 (Ga. L. 2003,
7 p. 4622), is amended by revising Section 1.11 as follows:

8 "SECTION 1.11.

9 Corporate boundaries.

10 (a) The boundaries of this city shall be those existing on the effective date of this charter
11 including all former annexations by legislative Act and ordinance, with such alterations as
12 may be made from time to time by local law or in any other manner provided by general
13 state law. That certain map depicting the corporate limits of the City of Buford, Georgia,
14 duly adopted and approved by the city commission on March 10, 2003, is hereby
15 incorporated by reference. The boundaries of this city at all times shall be shown on a map,
16 a written description, or any combination thereof, to be retained permanently in the office
17 of the city clerk, to be designated, as the case may be as the "(Official Map or Description)
18 of the Corporate Limits of the City of Buford, Georgia." Photographic, typed, or other
19 copies of such map or description, certified by the city clerk, shall be admitted as evidence
20 in all courts and shall have the same force and effect as the original map or description.

21 (b) The corporate territory of this city shall additionally include the following tax parcels,
22 as such existed as of January 1, 2016, as shown on the official tax map maintained by the
23 Tax Commissioner of Gwinnett County, Georgia and the official tax map maintained by
24 the Tax Commissioner of Hall County, Georgia:
