A BILL TO BE ENTITLED
AN ACT

1 To amend an Act providing for the election of the members of the board of education for
2 Clinch County, approved March 28, 1985 (Ga. L. 1985, p. 4918), as amended, so as to
3 change the description of education districts; to provide for definitions and inclusions; to
4 provide for continuation in office of current members; to provide for effective dates; to
5 provide for related matters; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 An Act providing for the election of the members of the board of education for Clinch
9 County, approved March 28, 1985 (Ga. L. 1985, p. 4918), as amended, is amended by
10 revising Section 3 and Section 4 as follows:

11 "SECTION 3.

12 (a) For the purpose of electing members of the board of education, the Clinch County School
13 District shall be divided into five education districts. Districts 1, 2, 3, 4 and 5 shall be and
14 correspond to those five numbered districts described in Appendix A attached to and made

15 a part of this Act and further identified as 'User: Clinch Co. Plan Name: ClinchCCSB-2022
16 Plan Type: Local'.

17 (b)(1) For the purposes of such plan:

18 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
19 provided in the report of the Bureau of the Census for the United States decennial
20 census of 2020 for the State of Georgia. The separate numeric designations in a district
21 description which are underneath a VTD heading shall mean and describe individual
22 Blocks within a VTD as provided in the report of the Bureau of the Census for the
23 United States decennial census of 2020 for the State of Georgia; and

24 (B) Except as otherwise provided in the description of any district, whenever the
25 description of any district refers to a named city, it shall mean the geographical
26 boundaries of that city as shown on the census maps for the United States decennial
27 census of 2020 for the State of Georgia.

28 (2) Any part of the Clinch County School District which is not included in any district
29 described in subsection (a) of this section shall be included within that district contiguous
30 to such part which contains the least population according to the United States decennial
31 census of 2020 for the State of Georgia.

32 (3) Any part of the Clinch County School District which is described in subsection (a)
33 of this section as being included in a particular district shall nevertheless not be included
34 within such district if such part is not contiguous to such district. Such noncontiguous
35 part shall instead be included within that district contiguous to such part which contains
36 the least population according to the United States decennial census of 2020 for the State
37 of Georgia.

38 SECTION 4.

39 (a) Those members of the Board of Education of Clinch County who are serving as such on
40 the effective date of this Act and any person selected to fill a vacancy in any such office shall

41 continue to serve as such members until the regular expiration of their respective terms of
42 office and upon the election and qualification of their respective successors.

43 (b) Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date of this Act,
44 shall continue to be designated as Districts 1, 2, 3, 4, and 5, respectively, but as newly
45 described under this Act, and on and after the effective date of this Act, such members of the
46 board serving from those former districts shall be deemed to be serving from and
47 representing their respective districts as newly described under this Act."

SECTION 2.

49 The provisions of this Act necessary to conduct elections for the members of the Board of
50 Education of Clinch County in 2022 shall become effective upon the approval of this Act by
51 the Governor or upon its becoming law without such approval. The remaining provisions
52 of this Act shall become effective on January 1, 2023.

SECTION 3.

54 All laws and parts of laws in conflict with this Act are repealed.
