A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act providing for a Board of Commissioners of Warren County, approved
- 2 March 23, 1977 (Ga. L. 1977, p. 3951), as amended, particularly by an Act approved
- 3 September 21, 2011 (Ga. L. 2011, Ex. Sess., p. 521), so as to change the description of the
- 4 commissioner districts; to provide for continuation in office of current board members; to
- 5 provide for related matters; to provide an effective date; to repeal conflicting laws; and for
- 6 other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act providing for a Board of Commissioners of Warren County, approved March 23,
- 10 1977 (Ga. L. 1977, p. 3951), as amended, particularly by an Act approved September 21,
- 11 2011 (Ga. L. 2011, Ex. Sess., p. 521), is amended by revising subsections (b) and (c) of
- 12 Section 1 as follows:
- 13 "(b) Those members of the Board of Commissioners of Warren County who are serving
- as such on the effective date of this Act and any person selected to fill a vacancy in any
- such office shall continue to serve as such members until the regular expiration of their
- 16 respective terms of office and upon the election and qualification of their respective

17 successors. On and after July 1, 2022, the Board of Commissioners of Warren County

- shall consist of three members, all of whom shall be elected from commissioner districts
- 19 described in subsection (c) of this section except for the member who is chairperson and
- who is elected at large.
- 21 (c)(1) For purposes of electing members of the board of commissioners, other than the
- chairperson, Warren County is divided into two commissioner districts. One member of
- 23 the board shall be elected from each such district. The two commissioner districts shall be
- 24 and correspond to those two numbered districts described in Appendix A attached to and
- 25 made a part of this Act and further identified as 'User: Warren Co. Plan Name:
- 26 warrence-2022 Plan Type: Local'.
- 27 (2) For the purposes of such plan:
- 28 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
- 29 provided in the report of the Bureau of the Census for the United States decennial
- census of 2020 for the State of Georgia. The separate numeric designations in a district
- description which are underneath a 'VTD' heading shall mean and describe individual
- 32 Blocks within a VTD as provided in the report of the Bureau of the Census for the
- United States decennial census of 2020 for the State of Georgia; and
- 34 (B) Except as otherwise provided in the description of any district, whenever the
- description of any district refers to a named city, it shall mean the geographical
- boundaries of that city as shown on the census maps for the United States decennial
- census of 2020 for the State of Georgia.
- 38 (3) Any part of Warren County which is not included in any district described in
- paragraph (1) of this subsection shall be included within that district contiguous to such
- 40 part which contains the least population according to the United States decennial census
- of 2020 for the State of Georgia.
- 42 (4) Any part of Warren County which is described in paragraph (1) of this subsection as
- being included in a particular district shall nevertheless not be included within such

district if such part is not contiguous to such district. Such noncontiguous part shall

- instead be included within that district contiguous to such part which contains the least
- population according to the United States decennial census of 2020 for the State of

47 Georgia."

48 SECTION 2.

- 49 Said Act is further amended by revising subsection (f) of Section 2 as follows:
- 50 "(f) Commissioner Districts 1 and 2, as they exist on the effective date of this Act, shall
- 51 continue to be designated as Commissioner Districts 1 and 2, respectively, but as newly
- 52 described under this Act; such members of the board serving from those former
- commissioner districts shall be deemed to be serving from and representing their respective
- 54 districts as newly described under this Act. Nothing in this subsection shall affect the
- 55 terms of office of such members of the board in office on the effective date of this
- subsection. Such sitting members shall serve out the terms of office for which such
- 57 members were elected."

58 SECTION 3.

59 This Act shall become effective on July 1, 2022.

SECTION 4.

61 All laws and parts of laws in conflict with this Act are repealed.
