## AS PASSED SENATE

## A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act creating a Board of County Commissioners of Hancock County, approved
- 2 October 5, 1885 (Ga. L. 1884-85, p. 435), as amended, particularly by an Act approved
- 3 May 6, 2013 (Ga. L. 2013, p. 4328), so as to change the description of the commissioner
- 4 districts; to provide for definitions and inclusions; to provide for the continuation in office
- 5 of current members; to provide for related matters; to provide an effective date; to repeal
- 6 conflicting laws; and for other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act creating a Board of County Commissioners of Hancock County, approved
- 10 October 5, 1885 (Ga. L. 1884-85, p. 435), as amended, particularly by an Act approved
- 11 May 6, 2013 (Ga. L. 2013, p. 4328), is amended by revising subsections (b) and (c) of
- 12 Section II as follows:

- 13 "(b) For the purpose of electing members of the board other than the chairperson, Hancock
- 14 County shall be divided into four commissioner districts. Commissioner Districts 1, 2, 3,
- and 4 shall be and correspond to those four numbered districts described in Appendix A
- attached to and made a part of this Act and further identified as 'User: SD26 Plan Name:

hancockccsb-legdraft-2022 Plan Type: Local'. The chairperson shall be elected by the electors of the entire county.

- 19 (c)(1) For the purposes of such plan:
- 20 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
- 21 provided in the report of the Bureau of the Census for the United States decennial
- census of 2020 for the State of Georgia. The separate numeric designations in a district
- description which are underneath a VTD heading shall mean and describe individual
- 24 Blocks within a VTD as provided in the report of the Bureau of the Census for the
- United States decennial census of 2020 for the State of Georgia; and
- 26 (B) Except as otherwise provided in the description of any district, whenever the
- description of any district refers to a named city, it shall mean the geographical
- boundaries of that city as shown on the census maps for the United States decennial
- census of 2020 for the State of Georgia.
- 30 (2) Any part of Hancock County which is not included in any district described in
- 31 subsection (b) of this section shall be included within that district contiguous to such part
- which contains the least population according to the United States decennial census
- of 2020 for the State of Georgia.
- 34 (3) Any part of Hancock County which is described in subsection (b) of this section as
- being included in a particular district shall nevertheless not be included within such
- district if such part is not contiguous to such district. Such noncontiguous part shall
- instead be included within that district contiguous to such part which contains the least
- population according to the United States decennial census of 2020 for the State of
- 39 Georgia."

40 SECTION 2.

- 41 (a) Those members of the Board of County Commissioners of Hancock County who are
- 42 serving as such on the effective date of this Act and any person selected to fill a vacancy in

43 any such office shall continue to serve as such members until the regular expiration of their

- 44 respective terms of office and upon the election and qualification of their respective
- 45 successors.
- 46 (b) Commissioner Districts 1, 2, 3, and 4, as they exist immediately prior to the effective
- 47 date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, and 4,
- 48 respectively, but as newly described under this Act, and on and after the effective date of this
- 49 Act, such members of the board serving from those former commissioner districts shall be
- 50 deemed to be serving from and representing their respective districts as newly described
- 51 under this Act.

52 SECTION 3.

53 This Act shall become effective on January 1, 2023.

SECTION 4.

55 All laws and parts of laws in conflict with this Act are repealed.
