A BILL TO BE ENTITLED

AN ACT

1 To amend an Act providing a new charter for the City of Ringgold, approved May 6, 2009
2 (Ga. L. 2009, p. 3624), as amended, so as to revise the corporate limits of said city; to
3 provide for related matters; to repeal conflicting laws; and for other purposes.

4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

5 **SECTION 1.**

6 An Act providing a new charter for the City of Ringgold, approved May 6, 2009 (Ga. L.
7 2009, p. 3624), as amended is amended in Section 1.11 by adding a new subsection to read
8 as follows:

9 "(d) Notwithstanding in subsections (a) through (c) of this section, or any other provision
10 of local law to the contrary, the corporate limits of the city shall not include the following
11 territory:

12 (1) All that tract or parcel of land lying and being in Land Lot 138 and 139 of the 28th
13 District, Third Section of Catoosa County, Georgia, being Lot One (1) of the Alvin
14 Mashburn Subdivision and shown recorded in the records of the Superior Court of
15 Catoosa County, at Deed Book 1084, Page 658.

16 (2) All that tract or parcel of land lying and being in Land Lot 151 of the 28th District,
17 Third Section of Catoosa County, Georgia, and shown recorded in the records of the
18 Superior Court of Catoosa County, at Deed Book 1084, Page 658.

19 (3) All that tract or parcel of land lying and being in Original Land Lot Nos. 138, 139,
20 and 151, in the 28th District, 3rd Section of Catoosa County, Georgia, being known and
21 designated as Lot No. 2 SHILOH COMMONS, as shown by plat of record in Plat
22 Book 21, Page 134, in the Office of the Clerk of the Superior Court of Catoosa County,
23 Georgia, and shown recorded in the records of the Superior Court of Catoosa County, at
24 Deed Book 1425, Page 147.

25 (4) All that tract or parcel of land lying and being in Original Land Lot 139 of the 28th
26 District, 3rd Section of Catoosa County, Georgia, being known and designated as Lot
27 No. 4 Shiloh Commons, Lot 3 Resub, as shown on a plat of said property record in Plat
28 Book 23, Page 220, in the Office of the Clerk of the Superior Court of Catoosa County,
29 Georgia, and shown recorded in the records of the Superior Court of Catoosa County, at
30 Deed Book 1892, Page 148.

31 (5) The right of way of State Route 2, also known as Battlefield Parkway, from the
32 southeastern most point of the territory described in paragraphs (1) through (4) of this
33 subsection to the intersection of such route with the centerline of the right of way of State
34 Route 401, also known as Interstate 75."

35 **SECTION 2.**

36 All laws and parts of laws in conflict with this Act are repealed.
