A BILL TO BE ENTITLED AN ACT

- 1 To amend Code Section 20-4-37 of the Official Code of Georgia Annotated, relating to the
- 2 Office of College and Career Transitions and powers and duties, so as to change the name
- 3 of the Office of College and Career Transitions to the Office of College and Career
- 4 Academies; to provide for increased technical skills; to provide for collaboration between the
- 5 Technical College System of Georgia and certain entities to support efforts to recruit new
- 6 industries and expand existing industries; to provide for related matters; to provide for an
- 7 effective date; to repeal conflicting laws; and for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

- 10 Code Section 20-4-37 of the Official Code of Georgia Annotated, relating to the Office of
- 11 College and Career Transitions and powers and duties, is amended by revising subsections
- 12 (b), (c), and (g) and by adding a new subsection to read as follows:
- 13 "(b) As used in this Code section, the term:
- 14 (1) 'Board' means the State Board of the Technical College System of Georgia.
- 15 (2) 'Certification' means a formal process established by the Office of College and Career
- 16 Transitions Academies, and approved by the board, in which college and career
- academies successfully demonstrate appropriate levels of student achievement and

technical skill development, community sustainability, work force development, and school level governance.

- 20 (3) 'Charter petitioner' means a local board of education, group of local boards of
- education, private individual, private organization, state or local public entity, or any
- group of these that submits a petition for a charter in cooperation with one or more
- postsecondary institutions which have petitioned to establish a college and career
- academy as a charter school pursuant to Article 31 or Article 31A of Chapter 2 of this
- 25 title.
- 26 (4) 'Charter school' shall mean the schools included in paragraph (3) of Code Section
- 27 20-2-2062 and in paragraph (5) of Code Section 20-2-2081.
- 28 (5) 'College and career academy' means a specialized school established as a charter
- school or pursuant to a contract for a strategic waivers school system or charter system,
- which formalizes a partnership that demonstrates a collaboration between business,
- industry, and community stakeholders to advance the technical skills needed for work
- force development between one or more local boards of education, a private individual,
- a private organization, or a state or local public entity in cooperation with one or more
- postsecondary institutions. A charter school, charter system, or strategic waivers school
- 35 system contract establishing a college and career academy shall include provisions
- requiring that the college and career academy have a governing board reflective of the
- 37 school community and the partnership with decision-making authority and requiring that
- 38 governing board members complete initial and annual governance training, including, but
- not limited to, best practices on school governance, the constitutional and statutory
- 40 requirements relating to public records and meetings, and the requirements of applicable
- 41 statutes and rules and regulations.
- 42 (6) 'Office' means the Office of College and Career Transitions Academies established
- pursuant to subsection (c) of this Code section.

44 (7) 'Postsecondary institution' means a local technical college, community college,

- university, or other postsecondary institution operating under the authority of the
- 46 Technical College System of Georgia or the University System of Georgia or other not
- for profit postsecondary institution accredited by the Southern Association of Colleges
- and Schools.
- 49 (8) 'Start-up costs' means initial operating or capital costs, including, but not limited to,
- 50 costs of improving real property.
- 51 (9) 'Supplemental funding' means funding for purposes other than start-up costs which
- are related to the establishment and operation of college and career academies.
- 53 (c) The Office of College and Career Transitions Academies shall be established within
- 54 the Technical College System of Georgia to coordinate the efforts by the State Board of
- 55 Education, the University System of Georgia, the Technical College System of Georgia,
- and other not for profit postsecondary institutions accredited by the Southern Association
- of Colleges and Schools in the professional development, curriculum support, and
- 58 development and establishment of college and career academies."
- f(g)(1) The office shall establish a certification process, in collaboration with the
- Department of Education, for approval by the board. The office shall be authorized to
- 61 certify college and career academies. The State Board of Education shall accept
- certification by the office as one component of determining compliance with charter and
- strategic waivers school system or charter system contract requirements. The State Board
- of Education may request supplemental information from charter petitioners, strategic
- waivers school systems, or charter systems.
- 66 (2) Any certification process established pursuant to paragraph (1) of this subsection
- shall require that the applicant demonstrates how the proposed college and career
- academy will increase student achievement and technical skill attainment, provide for
- dual credit and dual enrollment opportunities, increase work based learning opportunities,
- and address work force development needs; articulates how the collaboration between

business, industry, and community stakeholders will advance work force development;

- demonstrates local governance and autonomy; and shows other benefits that meet the
- 73 needs of the students and community.
- 74 (3) Certification by the office shall constitute a positive recommendation to the State
- Board of Education for renewal of a charter school or charter system pursuant to Code
- Section 20-2-2064.1 or an extension of a strategic waivers school system contract
- pursuant to Article 4 of Chapter 2 of this title."
- 78 "(1) The Technical College System of Georgia shall collaborate with the Workforce
- 79 <u>Development Board and the Department of Economic Development to support the efforts</u>
- 80 of College and Career Academies and local economic development partners to assist in the
- 81 recruitment of new industries and to expand existing industries by, but not limited to,
- 82 demonstrating the preparation of technically skilled high school graduates to be ready to
- 83 work within existing industries or industries being recruited to the state."

84 SECTION 2.

85 This Act shall become effective on January 1, 2022.

86 SECTION 3.

87 All laws and parts of laws in conflict with this Act are repealed.
