

## Senate Resolution 1EX

## A RESOLUTION

1 Adopting the Rules of the Senate for the 2020 Special Session of the General Assembly of  
2 Georgia; and for other purposes.

3 BE IT RESOLVED BY THE SENATE that the Rules of the Senate in effect at the  
4 suspension of the 2020 Regular Session of the General Assembly are hereby adopted as the  
5 Rules of the Senate for the 2020 Special Session with the following amendments:

6 **SECTION 1.**

7 Senate Rule 4-2.13 is amended by revising it as follows:

8 "4-2.13 Transmittal to the House

9 No bill or resolution shall be transmitted to the House on the day of passage thereof  
10 unless two-thirds of the Senators voting, provided the total vote constitutes a quorum,  
11 shall so order. Provided, during the last three legislative days of any regular session,  
12 and during the entirety of the 2020 special session, any bill, resolution, or other matter  
13 which requires action by the House shall be immediately transmitted to the House by  
14 the Secretary of the Senate. The Secretary shall also immediately transmit Senate  
15 bills and resolutions requiring House action on the twenty-eighth (28th) legislative  
16 day after any notice to reconsider is disposed of."

17 **SECTION 2.**

18 Senate Rule 6-7.1 is amended by revising subsection (c) as follows:

19 "(c) A notice of motion to reconsider a bill or resolution shall take precedence over  
20 a motion to transmit and shall have the effect of defeating the motion to transmit;  
21 except on the crossover day, ~~and~~ during the last three (3) days of any regular session,  
22 and during the entirety of the 2020 special session, a Senator must give notice  
23 immediately of his or her intention to move to reconsider, and the President or the  
24 designee of the President shall set a time during the day when the motion will be  
25 entertained, ~~so stating the time to the Senate; the time shall be at the discretion of the~~

26 ~~President or the designee of the President, but not less than ten minutes.~~ If the Senate  
27 is considering any other business at the time the motion to reconsider has been set to  
28 be entertained, the motion will be taken up upon conclusion of that business."

29 **SECTION 3.**

30 Senate Rule 6-7.5 is amended by revising it as follows:

31 "6-7.5 Effect of Motion; Return to General Calendar

32 All bills and resolutions reconsidered shall take their place at the foot of the calendar  
33 of bills then in order ~~for a third reading; however, during the last thirty-five (35)~~  
34 ~~legislative days of each session, a reconsidered bill or resolution which was passed~~  
35 ~~or adopted shall take its place at the foot of the Rules Calendar, and a reconsidered~~  
36 ~~bill or resolution which was defeated shall be placed on the General Calendar."~~
