A RESOLUTION

- 1 Creating the Senate Study Committee on Hearing Aids for Children; and for other purposes.
- 2 WHEREAS, the language development of children with partial or total hearing loss may be
- 3 impaired due to the hearing loss; and
- 4 WHEREAS, children learn the concept of spoken language through auditory stimuli, and the
- 5 language skills of children who have hearing loss improve when they are provided with
- 6 hearing aids and access to visual language upon the discovery of hearing loss; and
- 7 WHEREAS, providing hearing aids to children with hearing loss will reduce the costs borne
- 8 by this state, including special education, alternative treatments that would otherwise be
- 9 necessary if a hearing aid were not provided, and other costs associated with such hearing
- 10 loss; and
- 11 WHEREAS, a study of health insurance coverage for hearing aids for children and the
- 12 components of that coverage and options is critical when considering how to best address the
- 13 provision of hearing aids to children.
- 14 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE:
- 15 (1) **Creation of Senate study committee.** There is created the Senate Study Committee
- on Hearing Aids for Children.
- 17 (2) **Members and officers.** The committee shall be composed of five members of the
- Senate to be appointed by the President of the Senate. At least two of the members shall
- be from the minority party, including the Minority Leader. The President shall designate
- a member of the committee as chairperson of the committee.
- 21 (3) **Powers and duties.** The committee shall undertake a study of the conditions, needs,
- issues, and problems mentioned above or related thereto and recommend any action or
- legislation which the committee deems necessary or appropriate.

(4) **Meetings.** The chairperson shall call all meetings of the committee. The committee may conduct such meetings at such places and at such times as it may deem necessary or convenient to enable it to exercise fully and effectively its powers, perform its duties, and accomplish the objectives and purposes of this resolution.

- (5) **Allowances and funding.** The legislative members of the committee shall receive the allowances provided for in Code Section 28-1-8 of the Official Code of Georgia Annotated. The allowances authorized by this resolution shall not be received by any member of the committee for more than five days unless additional days are authorized. Funds necessary to carry out the provisions of this resolution shall come from funds
- Funds necessary to carry out the provisions of this resolution shall come from funds appropriated to the Senate.

(6) **Report.**

- (A) In the event the committee adopts any specific findings or recommendations that include suggestions for proposed legislation, the chairperson shall file a report of the same prior to the date of abolishment specified in this resolution, subject to subparagraph (C) of this paragraph.
- 39 (B) In the event the committee adopts a report that does not include suggestions for 40 proposed legislation, the chairperson shall file the report, subject to subparagraph (C) 41 of this paragraph.
- 42 (C) No report shall be filed unless the same has been approved prior to the date of 43 abolishment specified in this resolution by majority vote of a quorum of the committee. 44 A report so approved shall be signed by the chairperson of the committee and filed with
 - the Secretary of the Senate.
- 46 (D) In the absence of an approved report, the chairperson may file with the Secretary of the Senate a copy of the minutes of the meetings of the committee in lieu thereof.
- 48 (7) **Abolishment.** The committee shall stand abolished on December 1, 2016.
