- 1 Honoring the life and memory of Jim L. Gillis, Jr., and his exemplary service to the
- 2 community; and for other purposes.
- 3 WHEREAS, the State of Georgia mourns the loss of one of its most distinguished citizens
- 4 with the passing of Jim L. Gillis, Jr.; and
- 5 WHEREAS, Jim was born on October 2, 1916, the eldest of two sons of Jim L. Gillis, Sr.,
- 6 and Annie Lois Walker Gillis; and
- 7 WHEREAS, he was the valedictorian of his high school in Soperton and graduated from the
- 8 University of Georgia in 1937 with a bachelor's degree in forestry; and
- 9 WHEREAS, Jim diligently and conscientiously devoted innumerable hours of his time,
- 10 talents, and energy toward the betterment of his community and state as evidenced by his
- 11 superlative service as a Soil and Water Conservation District Supervisor, county
- 12 commissioner of Treutlen County for 40 years, president of the American Turpentine
- 13 Farmers Association, president of the Georgia Forestry Association, founder of the Ohoopee
- 14 River Soil and Water Conservation District, a member of the National Association of
- 15 Conservation Districts Hall of Fame, chairman of GBA, president of the Georgia Association
- of County Commissioners, a member of the Soperton Lions Club for more than 75 years, a
- beloved senator in the Georgia State Senate in 1938 and again from 1945 to 1946, a member
- 18 of the city council of Soperton, mayor of Soperton without opposition for five years,
- 19 chairman of the Association County Commissioners of Georgia Board, chairman of the
- 20 Georgia Forestry Commission, president of the Georgia Bankers Association, chairman of
- 21 the Bank of Soperton Board of Directors, and president of the Bank of Soperton from 1960
- 22 to 1981; and
- 23 WHEREAS, he received numerous awards and accolades over the course of his life,
- 24 including the title of Outstanding Conservationist of Georgia in 1960 and the 2007 Wise Owl

25 Award, and was inducted into the Georgia Foresters Hall of Fame and the GACDS Hall of

- 26 Fame; and
- 27 WHEREAS, he was a person of magnanimous strengths with an unimpeachable reputation
- 28 for integrity, intelligence, fairness, and kindness, and by the example he made of his life, he
- 29 made this world a better place in which to live; and
- 30 WHEREAS, a compassionate and generous man, Jim will long be remembered for his
- 31 service to his community and state and will be missed by all who had the great fortune of
- 32 knowing him.
