- 18 WHEREAS, Mr. Getachew-Smith attended Atlanta Public Schools; St. Andrew's School as
- 19 a Stouffer Foundation Scholar in Suwanee, Tennessee; Yale University in New Haven,
- 20 Connecticut; London School of Economics in England; and Harvard Law School in
- 21 Cambridge, Massachusetts; and
- WHEREAS, he is a conscientious family man who lives in Southwest Atlanta and stays
- 23 involved in his community through the homeowners association and community association,
- 24 serving as an advocate for improving the city's infrastructure, reducing crime, providing
