A RESOLUTION

- 1 Recognizing January 26, 2023, as National Guard Day at the state capitol; and for other
- 2 purposes.
- 3 WHEREAS, the Georgia Department of Defense provides combat-ready military forces to
- 4 combatant commanders and, upon the order of the governor, provides disaster response
- 5 capabilities to support civilian authorities; and
- 6 WHEREAS, the Georgia Department of Defense, consisting of 10,700 Army National Guard
- 7 soldiers, is headquartered at the Clay National Guard Center in Marietta, Georgia, and
- 8 includes the Georgia Army National Guard; the Georgia Air National Guard, embodying
- 9 2,900 Air National Guard airmen; and the Georgia State Defense Force, including 500 state
- 10 employees; and
- 11 WHEREAS, Georgia's Army National Guard is the eighth largest in the nation; it trains in
- 12 nearly 70 hometown armories and regional facilities in 55 counties across the state and
- 13 includes combat, combat support, and combat service support units; and
- 14 WHEREAS, Georgia's Army National Guard is organized into five major subordinate
- 15 commands, which are the Macon-based 48th Infantry Brigade Combat Team; the 648th

16 Maneuver Enhancement Brigade at Fort Benning; and the 78th Troop Command, 78th

- 17 Aviation Troop Command, and 201st Regional Support Group at the Clay National Guard
- 18 Center in Marietta; and
- 19 WHEREAS, the Georgia Air National Guard is the air power component of the State of
- 20 Georgia with airmen and officers assigned to the 116th Air Control Wing in Warner Robins,
- 21 the 165th Airlift Wing in Savannah, and six geographically separated units throughout
- 22 Georgia, all of which play an active role in supporting Georgia's homeland defense posture
- 23 by providing command and control, airlift, engineering, and communications; and
- 24 WHEREAS, the Georgia State Defense Force is a wholly volunteer unit of the Georgia
- 25 Department of Defense that provides training assistance to the combat forces of the Georgia
- 26 Army and Air National Guard, disaster response for every declared emergency within the
- 27 State of Georgia, and search and rescue at the direction of the governor and the adjutant
- 28 general of Georgia; and
- 29 WHEREAS, the Georgia National Guard has deployed more than 30,000 soldiers and airmen
- 30 throughout all geographic combatant commands since September 11, 2001; maintained a
- 31 steady overseas presence in support of contingency operations; maintained state partnerships
- 32 with the Country of Georgia and Republic of Argentina; and supported disaster and
- 33 emergency response missions with 3,200 guardsmen and state defense force volunteers
- 34 within the State of Georgia due to winter storms, hurricanes, COVID-19, and civil unrest;
- 35 and
- 36 WHEREAS, from the earliest muster of Georgia's colonial militia in 1733 to the present day,
- 37 Georgia's citizens have volunteered to defend our state and nation in the Georgia National
- 38 Guard, balancing civilian and family interests with a cause greater than themselves, and it

39 is abundantly fitting and proper that the outstanding accomplishments of these remarkable

- 40 and distinguished Georgians be appropriately recognized.
- 41 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body
- 42 recognize January 26, 2023, as National Guard Day at the state capitol and commend the
- 43 men and women of the Georgia National Guard for their strength, leadership, and courage
- 44 in their willingness to find meaning in something greater than themselves.
- 45 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed
- 46 to make appropriate copies of this resolution available for distribution to the public and the
- 47 press.
