## A RESOLUTION

- 1    Commending Mr. John J. (Sean) Martin Jr. for his dedicated service to the Georgia State
- 2    Senate; and for other purposes.
  
- 3    WHEREAS, Mr. John J. (Sean) Martin Jr. was born in Austria into a military family of John
- 4    Sr. (Marty) and Joyce Martin and moved to the United States by ocean liner at the ripe old
- 5    age of two; and
  
- 6    WHEREAS, in 1972, Mr. Martin graduated from Marist High School in Atlanta, Georgia,
- 7    having distinguished himself at this all-male military school as captain of the Color Guard
- 8    whose responsibilities included the presentation of the colors on a daily basis and at

- 10   WHEREAS, Mr. Martin graduated from Georgia State University in 1976 with a bachelor's
- 11   degree in political science; and
  
- 12   WHEREAS, Mr. Martin began his service in the Georgia State Senate in the Office of the
- 13   Secretary of the Senate as a session assistant on "the Crew" in 1978 and served as reading
- 14   clerk for the Senate; and

15 WHEREAS, his love of the law and legislative process led him to the University of Georgia,  
16 where he earned his Doctor of Law in 1984, and to his admittance into the State Bar of  
17 Georgia in 1986; and

18 WHEREAS, Mr. Martin engaged in the private practice of law in Georgia and has had a  
19 profoundly positive effect on the many juvenile offenders that he represented, the judges  
20 before whom he has appeared, and the local officials with whom he has worked in the  
21 juvenile justice system; and

22 WHEREAS, Mr. Martin has taken time away from his son, Tyler; daughter, Shelley; and  
23 grandchildren, Luke, Kylie Jane, and McKenna, to serve the legislature; and

24 WHEREAS, he is known for his compassionate nature, willingness to listen, and most  
25 importantly, his remarkable dedication to his friends; and

26 WHEREAS, he is beloved and deeply admired by the staff of the Secretary of the Senate and  
27 by all who have come into contact with his calm and steady demeanor, his infectious smile,  
28 and his quick wit; and

29 WHEREAS, Mr. Martin will now be able to focus on his lumber mill, his woodworking, and  
30 his twin joys of hiking and exploration as he leads his intrepid crew of Pinewalkers over the  
31 many backwoods trails and rivers of Georgia.
