- 13 WHEREAS, he held a variety of positions, including commanding a civil engineer squadron
- 14 at Dobbins Air Reserve Base. The culmination of his career was serving at the Pentagon
- 15 immediately after the 9/11 attack and being deployed to Southwest Asia; and
- 16 WHEREAS, he graduated from Georgia State College of Law in 1988 and had a successful
- 17 law practice with Alex and Wade Crumbly in McDonough. He argued cases before the
- 18 Georgia Court of Appeals and the Supreme Court of Georgia; and
- 19 WHEREAS, Judge Chafin has been active in community organizations and charitable
- 20 activities; he is most proud of being a founding director of A Friend's House, Henry County's
- 21 shelter for children in need; and
