## A RESOLUTION

1	Creating the Senate Consolidation of State Fire Safety Services Study Committee; and for
2	other purposes.
3	WHEREAS, consolidating state fire safety services into a single operating department or
4	division may bring greater efficiency to the provision of fire safety services in this state; and
5	WHEREAS, establishing a commissioner of fire safety to lead such a department or division
6	may provide for and bring increased expertise and command to state fire safety matters and
7	concerns; and
8	WHEREAS, study is needed on consolidating state fire safety services to determine the
9	benefits and efficiencies of such a consolidation.
10	NOW, THEREFORE, BE IT RESOLVED BY THE SENATE:
11	(1) Creation of Senate study committee. There is created the Senate Consolidation of
12	State Fire Safety Services Study Committee.
13	(2) <b>Members and officers.</b> The committee shall be composed of five members of the
14	Senate to be appointed by the President of the Senate. The President shall designate a
15	member of the committee as chairperson of the committee.
16	(3) <b>Powers and duties.</b> The committee shall undertake a study of the conditions, needs,
17	issues, and problems mentioned above or related thereto and recommend any action or
18	legislation which the committee deems necessary or appropriate.
19	(4) <b>Meetings.</b> The chairperson shall call all meetings of the committee. The committee
20	may conduct such meetings at such places and at such times as it may deem necessary or
21	convenient to enable it to exercise fully and effectively its powers, perform its duties, and
22	accomplish the objectives and purposes of this resolution.
23	(5) Allowances and funding.

(A) The legislative members of the committee shall receive the allowances provided

(B) The allowances authorized by this resolution shall not be received by any member of the committee for more than five days unless additional days are authorized. Funds necessary to carry out the provisions of this resolution shall come from funds appropriated to the Senate.

## (6) **Report.**

- (A) In the event the committee adopts any specific findings or recommendations that include suggestions for proposed legislation, the chairperson shall file a report of the same prior to the date of abolishment specified in this resolution, subject to subparagraph (C) of this paragraph.
- (B) In the event the committee adopts a report that does not include suggestions for proposed legislation, the chairperson shall file the report, subject to subparagraph (C) of this paragraph.
- (C) No report shall be filed unless the same has been approved prior to the date of abolishment specified in this resolution by majority vote of a quorum of the committee. A report so approved shall be signed by the chairperson of the committee and filed with the Secretary of the Senate.
- (D) In the absence of an approved report, the chairperson may file with the Secretary of the Senate a copy of the minutes of the meetings of the committee in lieu thereof.
- (7) **Abolishment.** The committee shall stand abolished on December 1, 2020.
