Senate Resolution 300

A RESOLUTION

- 1 Creating the Senate University Fees Study Committee; and for other purposes.
- 2 WHEREAS, postsecondary education is a critical investment in Georgia's future work force
- 3 and the health and vitality of the state's economy; and
- 4 WHEREAS, tuition and fees have increased significantly in all sectors of postsecondary
- 5 education in the past decade, forcing many students to take on the burden of heavy debt, to
- 6 abandon postsecondary education, or both; and
- 7 WHEREAS, many postsecondary students attend school part time due to work or family
- 8 commitments; and
- 9 WHEREAS, university fees are an increasingly costly part of the price of postsecondary
- 10 education; and
- 11 WHEREAS, postsecondary institutions often require part-time students to pay full-time fees;
- 12 and

13 WHEREAS, the General Assembly needs to review the fees associated with the cost of

- 14 postsecondary education as such fees relate to the overall cost of tuition and determine more
- 15 affordable solutions, particularly for part-time students and graduate students, and make
- 16 recommendations regarding potential changes to the tuition and associated fees structure.

17 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE:

- 18 (1) Creation of Senate study committee. There is created the Senate University Fees
- 19 Study Committee.
- 20 (2) **Members and officers.** The committee shall be composed of five members as
- 21 follows:
- 22 (A) The chairperson of the Senate Higher Education Committee, who shall serve as
- chairperson of the committee;
- 24 (B) Two members of the Senate appointed by the President of the Senate, comprising
- one member from the majority caucus and one member from the minority caucus;
- 26 (C) The chancellor of the University System of Georgia, or the chancellor's
- designee; and
- 28 (D) The president of the Georgia Student Finance Commission, or the president's
- designee.
- 30 (3) **Powers and duties.** The committee shall undertake a study of the conditions, needs,
- issues, and problems mentioned above or related thereto and recommend any action or
- 32 legislation which the committee deems necessary or appropriate. The committee shall
- be authorized to request the assistance of the University System of Georgia to assist the
- 34 committee in its study.
- 35 (4) **Meetings.** The chairperson shall call all meetings of the committee. The committee
- may conduct such meetings at such places and at such times as it may deem necessary or
- 37 convenient to enable it to exercise fully and effectively its powers, perform its duties, and
- accomplish the objectives and purposes of this resolution.

39 (5) Allowances, expenses, and funding.

40 (A) The legislative members of the committee shall receive the allowances provided 41 for in Code Section 28-1-8 of the Official Code of Georgia Annotated.

- 42 (B) Members of the committee who are state officials, other than legislative members, 43 or who are state employees shall receive no compensation for their services on the 44 committee, but they may be reimbursed for expenses incurred by them in the
- performance of their duties as members of the committee in the same manner as they
- are reimbursed for expenses in their capacities as state officials or employees.
- 47 (C) Members of the committee who are not legislators, state officials, or state
- 48 employees shall receive a daily expense allowance in an amount the same as that
- specified in subsection (b) of Code Section 45-7-21 of the Official Code of Georgia
- Annotated, as well as the mileage or transportation allowance authorized for state
- 51 employees.
- 52 (D) The allowances and expenses authorized by this resolution shall not be received
- by any member of the committee for more than five days unless additional days are
- authorized. Funds necessary to carry out the provisions of this resolution shall come
- from funds appropriated to the Senate; except that funds for the reimbursement of the
- 56 expenses of state officials, other than legislative members, and state employees shall
- 57 come from funds appropriated to or otherwise available to their respective agencies.

(6) **Report.**

- (A) In the event the committee adopts any specific findings or recommendations that
- include suggestions for proposed legislation, the chairperson shall file a report of the
- same prior to the date of abolishment specified in this resolution, subject to
- subparagraph (C) of this paragraph.
- (B) In the event the committee adopts a report that does not include suggestions for
- proposed legislation, the chairperson shall file the report, subject to subparagraph (C)
- of this paragraph.

66 (C) No report shall be filed unless the same has been approved prior to the date of 67 abolishment specified in this resolution by majority vote of a quorum of the committee. 68 A report so approved shall be signed by the chairperson of the committee and filed with 69 the Secretary of the Senate. Any member of the committee may file a minority report 70 that shall accompany the majority report.

- (D) In the absence of an approved report, the chairperson may file with the Secretary of the Senate a copy of the minutes of the meetings of the committee in lieu thereof.
- 73 (7) **Abolishment.** The committee shall stand abolished on December 1, 2021.
