## BE IT RESOLVED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

8 Article VII, Section I, Paragraph II of the Constitution, relating to limitations on taxing

9 power, is amended by adding a new subparagraph (c) to read as follows:

10 "(c)(1) Effective on and after January 1, 2017, no tax on income shall be imposed at a

rate in excess of 5.5 percent. Thereafter, on January 1 of each succeeding year, such

maximum income tax rate shall be reduced by one-half of 1 percent until such tax rate is

zero. The General Assembly by general law shall provide for the recalculation and

revision of any income tax rates that are in effect on the effective date of this

subparagraph to comply with the provisions of this subparagraph.

16 (2) The General Assembly shall be authorized to impose an income tax in excess of the

rate provided for in this subparagraph only upon a finding that an emergency condition

exists in the state for which an income tax must be imposed. No such finding and tax

shall become law unless such finding and tax shall receive the affirmative votes of at least

two-thirds of all the members to which each house is entitled, which vote shall so appear

on the journal of each house, and be approved by the Governor. No such income tax

shall be effective for a period of more than two calendar years unless such tax is renewed by a finding of a continuing emergency condition and a renewal of such income tax by

the affirmative votes of at least two-thirds of all the members to which each house is

entitled, which vote shall so appear on the journal of each house, and approval by the

- 33 () NO income taxes?"
- 34 All persons desiring to vote in favor of ratifying the proposed amendment shall vote "Yes."
- 35 All persons desiring to vote against ratifying the proposed amendment shall vote "No." If
- 36 such amendment shall be ratified as provided in said Paragraph of the Constitution, it shall
- 37 become a part of the Constitution of this state.
