A RESOLUTION

- 1 Celebrating and commending Alpha Kappa Alpha Sorority, Incorporated® Kappa Omega
- 2 Chapter for 100 years of service to all mankind; and for other purposes.
- 3 WHEREAS, Alpha Kappa Alpha Sorority, Incorporated® (AKA), an international service
- 4 organization, was founded on the campus of Howard University in Washington, D.C., on
- 5 January 15, 1908, and has the distinction of being the first Greek-letter organization
- 6 established by African American college-educated women; and
- 7 WHEREAS, Alpha Kappa Alpha Sorority, Incorporated® is composed of more than 325,000
- 8 initiated members in graduate and undergraduate chapters located across 12 countries,
- 9 including the United States, Bahamas, Bermuda, Canada, Dubai, Germany, Japan, Liberia,
- 10 Nigeria, South Korea, South Africa, and the United States Virgin Islands; and
- 11 WHEREAS, early in the third decade of the twentieth century, a group of AKA women
- 12 living in Atlanta, Georgia, were compelled by their own experiences as members of AKA
- 13 to organize the first graduate chapter in the State of Georgia to share with other young
- 14 women for their own personal enrichment as well as to ensure and enhance the contributions
- and services they would provide for the benefit of all; and

16 WHEREAS, this group of ten outstanding women included Marie Woolfolk Taylor, one of

- 17 the original founding members of AKA at Howard University in 1908; Adelaide Smith
- 18 (Turner); Louise Shivery; Madeline Smith Davis; Eva Conner; Hattie Watson; Caroline Bond
- 19 Day; Ruth B. Prince; and Floy S. Brown, all of whom came together and organized the first
- 20 graduate chapter, Kappa Omega, in Atlanta; and
- 21 WHEREAS, the Kappa Omega chapter was chartered on March 1, 1923, and was fortunate
- 22 to have Marie Woolfolk Taylor, a founding member of Alpha Kappa Alpha Sorority,
- 23 Incorporated®, serve as one of its charter members and as its first chapter president; and
- 24 WHEREAS, at the time of the chartering of the Kappa Omega chapter, lynchings in the south
- 25 were not uncommon and Jim Crow laws were enforced. Despite the institutionalized
- 26 discrimination during the early decades, Kappa Omega chapter members implemented
- 27 programs addressing the economic, social, political, and moral climate of the times; and
- WHEREAS, the Kappa Omega chapter has a rich legacy that now spans ten decades; 100
- 29 years of giving service to the Atlanta community. Since 1923, Kappa Omega chapter
- 30 members have served as educators, lawyers, judges, doctors, nurses, business executives,
- 31 entrepreneurs, engineers, and political and civic-minded leaders from innumerable other
- 32 professions. Members of the Kappa Omega chapter have been steadfast in serving their
- 33 communities by volunteering their time, talents, and resources to advocate for the good of
- all mankind from 1923 to 2023 and beyond; and
- 35 WHEREAS, for a century, the Kappa Omega chapter has aligned its programming and
- 36 community service in the metropolitan Atlanta area with Alpha Kappa Alpha Sorority,
- 37 Incorporated® targets and initiatives. These include, but are not limited to, feeding and
- 38 clothing children and the homeless; coordinating voter registration drives; increasing social

and civic responsibility in the African American community; promoting good health in the
African American community; focusing on women's health including providing

- 41 mammograms for women; assisting high school students with the college application
- 42 process; supporting historically black colleges and universities; increasing awareness of the
- 43 importance of financial literacy, as in being fiscally fit; showcasing the arts; and leaving a
- 44 global footprint here and abroad; and
- 45 WHEREAS, the Kappa Omega chapter has supported many community partners, such as
- 46 Carrie Steele Pitts Home, a private, nonprofit, and non-discriminatory child caring agency
- 47 that provides community-based child welfare services and 24-hour state approved residency
- 48 for vulnerable youth by supporting their education initiatives with school supplies and
- 49 providing clothing and various other items as needed by the young residents; and
- 50 WHEREAS, Kappa Omega chapter members have held notable positions within Alpha
- 51 Kappa Alpha Sorority, Incorporated® on the regional and international level. These members
- 52 include Lucille M. Scott (Ivy Leaf Reporter), Margaret Davis Bowen (International
- 53 Secretary), Dr. Lucretia Payton Stewart (International Parliamentarian and International
- 54 Leadership Development Committee Chairman), Harriet Thomas (International Asst.
- 55 Secretary), and Dr. Mary Shy Scott (International First Vice President and 23rd International
- 56 President & CEO), as well as four regional directors, A. Cathryn Johnson, Sujette Fountain
- 57 Crank, Dr. Mary Shy Scott, and Dr. Lucretia Payton Stewart, and four cluster coordinators,
- 58 Malinda K. O'Neal, Mary Carolyn Menchan, Dr. Anne Watts, and Eva Stroud; and
- 59 WHEREAS, since its inception, the Kappa Omega chapter has achieved many notable
- accomplishments. The chapter has supervised the chartering of six undergraduate chapters
- as well as served as host for multiple Cluster Meetings, six Regional Conferences, three
- 62 International Conferences, and the 97th National Founders' Day. The Ivy Community

63 Foundation, formerly Kappa Omega Foundation, (Willieboyd M. Saddler, Chairman),

- 64 purchased the Ivy Community Center (1992), serving as a pillar and a beacon of hope to the
- 65 Atlanta community. The foundation sponsors fundraising activities and has awarded a myriad
- of scholarships throughout the years to college-bound students; and
- 67 WHEREAS, Kappa Omega members Marjorie H. Young and Yvonne McBride served as
- architects for the AKA Day at the Capitol (1994), which became an institutional framework
- 69 for all regions. The Ethel Hedgemon Lyle Leadership Academy was established (2005) by
- 70 Dr. Lucretia Payton Stewart (Deborah Sims, President). The Kappa Omega chapter presented
- 71 its First History Book in 2014 (Franka H. Young, President; Doris T. Stroud, Historian) at
- 72 the South Atlantic Regional Conference and 66th International Conference (2014), hosted
- 73 the Marie Woolfolk Taylor Historical Marker Unveiling Ceremony (2018) at the First
- 74 Congregational Church in Atlanta (Icey Johnson, President), served as host for the Metro
- 75 Atlanta Founders' Day in 2019 (Dr. LeKeisha D. Jackson, President), exemplified excellence
- 76 from 2018 to 2022, and is now soaring to greater heights of sisterhood and service in 2023
- 77 (Bridgette Grant, President); and
- 78 WHEREAS, the Kappa Omega chapter has for 100 years upheld the five basic tenets of the
- 79 mission of Alpha Kappa Alpha Sorority, Incorporated®, upon which it was founded, which
- are to cultivate and encourage high scholastic and ethical standards, to promote unity and
- 81 friendship among college women, to study and help alleviate problems concerning girls and
- women in order to improve their social stature, to maintain a progressive interest in college
- 83 life, and to be of Service to All Mankind.
- NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body
- 85 commend the Alpha Kappa Alpha Sorority, Incorporated® Kappa Omega Chapter and
- 86 celebrate its 100 years of service to Atlanta communities.

87 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed
