A RESOLUTION

- 1 Ratifying Governor Brian P. Kemp's Executive Order Nos. 05.10.21.02, 05.14.21.01,
- 2 05.21.21.01, and 05.28.21.03 suspending the collection of motor fuel and diesel fuel taxes;
- 3 and for other purposes.
- 4 WHEREAS, on May 7, 2021, a cybersecurity incident occurred against Colonial Pipeline
- 5 Company; and
- 6 WHEREAS, the cyberattack installed ransomware on Colonial Pipeline Company's
- 7 Information Technology systems resulting in the shutdown of crucial pipelines and halting
- 8 of all pipeline operations; and
- 9 WHEREAS, due to the on-going effects of the temporary shutdown of a primary fuel
- 10 pipeline, there existed an intermittent shortage of petroleum fuel in Georgia; and
- WHEREAS, the uninterrupted supply of transportation fuel is an essential need of the public
- and any perceived shortage threatens the public welfare; and
- 13 WHEREAS, in May 2021, under the authority granted in Code Section 38-3-51 of the
- 14 Official Code of Georgia Annotated, Governor Brian P. Kemp declared a state of emergency

due to the petroleum shortage caused by the cyberattack on Colonial Pipeline Company and

- 16 issued Executive Order Nos. 05.10.21.02, 05.14.21.01, 05.21.21.01, and 05.28.21.03, as a
- 17 necessary and appropriate action; and
- 18 WHEREAS, pursuant to Code Section 45-12-22 of the Official Code of Georgia Annotated,
- 19 the collection of motor fuel and diesel fuel taxes required by Code Section 48-9-3 was
- 20 suspended during the effective dates of the State of Emergency for Petroleum Shortage,
- 21 declared by Executive Order Nos. 05.10.21.02, 05.14.21.01, 05.21.21.01, and 05.28.21.03,
- 22 with such dates being May 10, 2021 through June 2, 2021; and
- 23 WHEREAS, pursuant to Code Section 45-12-22 of the Official Code of Georgia Annotated,
- 24 action by two-thirds of the General Assembly is necessary to ratify the suspension of
- 25 collection of motor fuel and diesel fuel taxes as declared by Executive Order Nos.
- 26 05.10.21.02, 05.14.21.01, 05.21.21.01, and 05.28.21.03.
- 27 NOW, THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY OF
- 28 GEORGIA that the members of this body ratify the suspension of collection of motor fuel
- and diesel fuel taxes as declared by Executive Order Nos. 05.10.21.02, 05.14.21.01,
- 30 05.21.21.01, and 05.28.21.03 issued by Governor Brian P. Kemp in response to a state of
- 31 emergency for petroleum shortage.
- 32 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives and the
- 33 Secretary of the Senate are authorized and directed to make appropriate copies of this
- 34 resolution available for distribution to Governor Brian P. Kemp and members of the public
- 35 and the press.
