A RESOLUTION

- 1 Honoring Judge Ronald B. Ramsey, Sr., on the occasion of his 25th year as a member of the
- 2 State Bar of Georgia and commending his years of service to the Georgia State Senate; and
- 3 for other purposes.
- 4 WHEREAS, Judge Ronald B. Ramsey, Sr., accepted the oath as an attorney and counselor
- 5 at law on February 7, 1992, and seven years later, he was appointed as the first African
- 6 American to serve as a municipal court judge on the Municipal Court of Stone Mountain; and
- 7 WHEREAS, seven years later, on January 8, 2007, Honorable Ronald B. Ramsey, Sr.,
- 8 accepted the oath as a Georgia State Senator for District 43 of Georgia, for which he served
- 9 admirably for nine sessions of the Georgia General Assembly; and
- 10 WHEREAS, during his tenure as a Georgia State Senator, Judge Ramsey served as Chairman
- of the Urban Affairs Committee, Chairman of the DeKalb County Legislative Delegation,
- 12 Chairman of the Rockdale County Legislative Delegation, Vice Chair of the Special
- 13 Judiciary Committee, and a member of the Judiciary Committee; and
- 14 WHEREAS, from 2010 through 2014, he was the only African American attorney serving
- 15 in the Georgia State Senate and was the only African American appointed by Governor
- 16 Nathan Deal in 2011 to serve on the Criminal Justice Reform Council, which was the
- 17 foundation and catalyst for a series of historic criminal justice reform initiatives passed by
- 18 the General Assembly; and
- 19 WHEREAS, as a Georgia State Senator, he also authored several pieces of legislation to
- 20 promote civil rights, voting rights, veterans' rights, and criminal justice, and he was named
- 21 "Legislator Of The Year" by state-wide teacher organizations twice, "Exemplary Legislator"
- 22 by the Democratic Party of Rockdale County, and "Legislative Hero" by the Stonecrest
- 23 Alliance; and

24 WHEREAS, on June 30, 2015, Judge Ramsey was appointed by Governor Nathan Deal to

- 25 the newly formed State Court of DeKalb County Traffic Division to reform the
- administration of justice in DeKalb County, and later that year he fulfilled a lifelong goal of
- 27 being admitted to the Bar of the Supreme Court of the United States of America; and
- 28 WHEREAS, Judge Ramsey continues to support the legislative process as a member of the
- 29 Council of State Court Judges Legislative Task Force; and
- 30 WHEREAS, he has received numerous awards and honors for his service to humanity and
- 31 the legal community and has been designated as a "Mentor" by the State Bar of Georgia to
- 32 mentor and guide new attorneys in the practice of law, and he was further honored with the
- 33 "Distinguished Alumni Award" by John Marshall Law School in 2011 and the Thurgood
- 34 Marshall Justice and Service Award by the DeKalb Branch of the NAACP in 2016.
- 35 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body
- 36 honor and commend Judge Ronald B. Ramsey, Sr., for his service to the legal community
- and the State of Georgia and extend best wishes for continued health and happiness.
