Proposing an amendment to the Constitution so as to provide that members of the Senate 1 2 shall serve four-year terms of office; to provide that members of the Senate shall have limited 3 terms of office; to provide for related matters; to provide for the submission of this 4 amendment for ratification or rejection; and for other purposes.

BE IT RESOLVED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

7 Article III, Section II of the Constitution is amended by revising Paragraph V as follows:

8 "Paragraph V. *Election and term of members.* (a) The members of the General 9 Assembly shall be elected by the qualified electors of their respective districts. Members 10 of the House of Representatives shall serve for a term of two years and shall serve until the

11 time fixed for the convening of the next General Assembly. Members of the Senate shall

- 12 serve for a term of four years and shall serve until the time fixed for the convening of the 13 next General Assembly.
- 14 (b) The members of the General Assembly in office on June 30, 1983, elected in the 15 November, 2014, general election shall serve out the remainder of the terms to which elected. 16

17 (c) The first election for members of the General Assembly House of Representatives 18 under this Constitution Paragraph shall take place on Tuesday after the first Monday in 19 November, 1984 2016, and subsequent elections biennially on that day until the day of 20 election is changed by law. The first election for members of the Senate under this 21 Paragraph shall take place on Tuesday after the first Monday in November, 2016, and 22 subsequent elections quadrennially on that day until the day of election is changed by law. 23 (d) Beginning with the members elected in the November, 2016, general election, 24 members of the Senate shall be limited to the greater of three full terms of office or 14 25 years in the Senate. The limitation in this subparagraph shall not apply to any term or part 26 of a term served prior to the second Monday in January, 2017."
