## A RESOLUTION

1 Congratulating and commending the State YMCA of Georgia's Youth Assembly on its 75th  
2 anniversary; and for other purposes.

3 WHEREAS, the State YMCA of Georgia and its Center for Civic Engagement and "Y" Club  
4 programs sponsor the Youth Assembly, among other programs, that cultivate youth civic  
5 engagement; and

6 WHEREAS, the State YMCA of Georgia's Youth Assembly is a model state legislature for  
7 high school students in which students serve as legislators, justices, attorneys, press corps  
8 members, and lobbyists; and

9 WHEREAS, participants in the Youth Assembly may run for the offices of Youth Governor,  
10 Lieutenant Governor, and Speaker of the House; and

11 WHEREAS, students participating in the Youth Assembly are also given the opportunity to  
12 explore the role the media plays in government by participating in the production of a daily  
13 newspaper; and

14 WHEREAS, established in 1946, the Youth Assembly conference takes place in the historic  
15 halls of the Georgia State Capitol, providing participants with an experience they will cherish  
16 for the rest of their lives; and

17 WHEREAS, this year, the Youth Assembly celebrates its 75th anniversary, and the State  
18 YMCA of Georgia celebrates over 90 years of excellence and tradition; and

19 WHEREAS, the 74th Youth Assembly was made up of many bright and eager young leaders,  
20 including: Youth Governors, David Mustard and Thomas Tucker; Lt. Governors, Nathan  
21 Touchberry and Langley Wooten; Speakers of the House, Samantha Ayoub and Kimi  
22 Powell; Presidents Pro Tem, Alex Garcia and Ty Hadley; Speakers Pro Tem of the House,

23 Dylan Henderson and Ben Norton; Chief Justices, Jasmin Elphic and Conner McMahon;
