- 5 committed citizens of Georgia; and
- 6 WHEREAS, he has diligently and conscientiously devoted innumerable hours of his time,
- 7 talents, and energy toward the betterment of his community and state as evidenced
- 8 dramatically by his superlative service with the Georgia State Senate; and
- 9 WHEREAS, Senator Mullis was first elected to the Georgia State Senate in 2000 to serve
- 10 Senate District 53 and is currently the longest serving Republican in the Senate, and he has
- 11 announced that he will not seek reelection; and
- 12 WHEREAS, born and raised in Chickamauga, Georgia, Senator Mullis was formerly a fire
- 13 chief and is an economic developer in Northwest Georgia for the Northwest Joint

- 19 Joint Committee, and he is the chairman emeritus of the Sportsman Caucus, whose mission
- 20 is to promote and protect hunting, fishing, and the Second Amendment; and
- 21 WHEREAS, he has been recognized by Georgia Trend magazine as one of the "100 Most
- 22 Influential People in Georgia" for six consecutive years, and *James Magazine* listed him as
- 23 one of the "Most Influential Political Leaders in Georgia" for eight consecutive years; and
- 24 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
- 25 Georgian be appropriately recognized by dedicating an intersection in his honor.
- 26 NOW, THEREFORE, BE IT RESOLVED AND ENACTED BY THE GENERAL
- 27 ASSEMBLY OF GEORGIA that the intersection of State Route 341 and Lee Clarkson Road
- 28 in Walker County is dedicated as the Senator Jeff Mullis Intersection.
- 29 BE IT FURTHER RESOLVED that the Department of Transportation is authorized and
- 30 directed to erect and maintain appropriate signs dedicating the Senator Jeff Mullis
- 31 Intersection.
