ADOPTED

A RESOLUTION

1 Dedicating certain portions of the state highway system; to provide for an effective date; to
2 repeal conflicting laws; and for other purposes.

3 **PART I**

4 WHEREAS, the State of Georgia lost one of its finest citizens and most dedicated law
5 enforcement officers with the tragic passing of Deputy Nicolas Blane Dixon on July 8, 2019;
6 and

7 WHEREAS, a native of Gainesville, Georgia, Deputy Dixon graduated from North Hall High
8 School and followed his lifelong dream to serve others as a law enforcement officer; and

9 WHEREAS, he served the Hall County Sheriff's Office Uniformed Patrol Division for three
10 years, where he had a well-earned reputation as a person of unquestioned integrity and
11 dedication to the sound principles of law enforcement; and

12 WHEREAS, his life was tragically cut short in the line of duty after he made a vehicle stop
13 of a burglary suspect and was shot during a gun fight after the suspect fled on foot; and

14 WHEREAS, Deputy Dixon exhibited extraordinary devotion to duty, outstanding loyalty,
15 fine leadership, and meticulous attention to detail in all his duties; and

16 WHEREAS, known as having a giant heart and generous spirit, Deputy Dixon was
17 passionate about his service as a police officer and was the embodiment of courage and
18 strength; and

19 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
20 Georgian be recognized appropriately by dedicating a bridge in his memory.

34 state earned him the respect and admiration of his colleagues and associates as a member of
35 the United States House of Representatives from 2005 to 2017; and

36 WHEREAS, in 2017, Dr. Price was appointed as the United States Secretary of Health and
37 Human Services; and

38 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
39 Georgian be recognized appropriately by dedicating a road in his honor.

98 serving as chair of NPU-S for nearly 20 years and as a founding member of the Southwest
99 Coalition of Concerned Citizens; and

181 Committee on Special Judiciary, making him the first African American chairperson for the
182 Georgia General Assembly; and

183 WHEREAS, in 1980, he was appointed a superior court judge, and in 1991 he retired from
184 the bench as an administrative law judge with the State Board of Workers' Compensation;
185 and

186 WHEREAS, during his career on the bench, he earned a reputation as a clear thinker and
187 hard worker, as a man whose strong convictions were supported by meticulous research and
188 careful consideration, and as an equitable, impartial leader whose decisions were governed
189 by the rules of honesty and fair play; and

190 WHEREAS, Judge Thompson's leadership and wisdom were instrumental to numerous
191 service organizations and the Civil Rights Movement; and

192 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished

368 as a founding member of Civic Leaders United Behind Youth (C.L.U.B.Y.), which raises
369 money for scholarships and Christmas funds for youth; and

370 WHEREAS, his strong desire to be involved in the future of his community led him to the
371 Georgia General Assembly, where he worked tirelessly for his beloved community and
372 served as chairman of the House Rules Committee; and

415 Japanese bomber planes and shot down two on December 12, 1941, just days after the attack
416 on Pearl Harbor; and

417 WHEREAS, Major Elrod was the first American to sink a Japanese warship from a fighter
418 aircraft when he dropped bombs on the destroyer, *Kisaragi*; and

419 WHEREAS, he lost his life during a battle on Wake Island shortly after crash landing there
420 and organizing a beach defense unit to push back the Japanese invasion; and

421 WHEREAS, Major Elrod was posthumously awarded a Medal of Honor, and a ship, the USS
422 *Elrod*, has been commissioned in his honor; and

423 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
424 Georgian be recognized appropriately by dedicating a bridge in his memory.
