- 21 Legislator of the year and currently serves as the chairman of the Georgia Legislative Black
- 22 Caucus, the largest in the nation; and
- 23 WHEREAS, he is the CEO of Coastal Health Solutions, Inc., a company that recognizes the
- 24 growing need to promote and employ dental allied health professionals who are experts in
- 25 their field; and
- 26 WHEREAS, Dr. Jackson's significant organizational and leadership talents, remarkable
- 27 patience and diplomacy, keen sense of vision, and sensitivity to the needs of the citizens of
- 28 this state have earned him the respect and admiration of his colleagues and associates; and
