- 3 WHEREAS, Dr. Georgianne Thomas has long been recognized by the citizens of this state
- 4 for the vital role that she has played in leadership and her deep personal commitment to the
- 5 welfare of the citizens of Georgia; and
- 6 WHEREAS, as an author, actress, educator, entrepreneur, and political activist, she has
- 7 diligently and conscientiously devoted innumerable hours of her time, talents, and energy
- 8 toward the betterment of her community and state; and
- 9 WHEREAS, after surviving breast cancer in 2002, she completed her doctoral degree in
- 10 French literature and founded the company Georgianne's Skin Treats; and
- 11 WHEREAS, Dr. Thomas has served with honor and distinction as an adjunct professor at
- 12 Clark Atlanta University and Atlanta Metropolitan State College; as a program manager
- 13 assisting victims of domestic violence with the City of Atlanta Municipal Court; as former
- 14 mayoral-appointed chair of the Atlanta Sister Cities Commission; as a Georgia delegate to
- 15 the National Summit on Africa; as former president of the Atlanta Chapter of the National
- 16 Association of Media Women; and as a pioneer member of the Atlanta Association of Black
- 17 Journalists (AABJ); and her vision and unyielding commitment to the City of Atlanta and to
- 18 bringing international awareness and involvement to preventing domestic violence have set
- 19 the standard for public service; and
- 20 WHEREAS, as co-chair of the Sister Cities International, Inc., convention, she brought the
- 21 only convention to Atlanta in the 50 year history of the international organization, was a
- 22 recipient of the 2006 Distinguished Volunteer Award with Sister Cities International, and
- 23 was honored for her contribution to international awareness and involvement in the City of

24 Atlanta with the Delta Torch Award in 2003, which was presented by the Atlanta Alumnae

- 25 Chapter of Delta Sigma Theta Sorority, Inc.; and
- 26 WHEREAS, in addition to other exceptional accomplishments of her political life, Dr.
- 27 Thomas served for four years in the Fulton County Democratic Party; was the recipient of
- 28 an Atlanta City Council proclamation for outstanding work in the community; is an
- 29 appointee to the Advisory Council of the Hemisphere, Inc., Free Trade Area of the Americas;
- and was named an Honorary State Senator in Georgia in 2006; and
- 31 WHEREAS, Dr. Thomas's significant organizational and leadership talents, her remarkable
- 32 patience and diplomacy, her keen sense of vision, and her sensitivity to the needs of the
- 33 citizens of this state have earned her the respect and admiration of her colleagues and
- 34 associates; and

- 36 remarkable and distinguished Georgian be appropriately recognized.
