

Chair Tarnas, Vice Chair Poepoe, and members of the Committee:

The Department of Law Enforcement (DLE) strongly supports House Bill 279. This bill strengthens Hawaii's firearm laws by establishing clear regulations on the transportation and possession of firearm parts, implementing stricter controls to prevent the illegal assembly of firearms, particularly 'ghost guns,' and enhancing penalties for violations.

The DLE recognizes that the unrestricted movement of firearm parts presents a significant public safety concern, especially with the rising threat of untraceable ghost guns. This legislation addresses this critical gap by requiring firearm parts to be transported only between authorized locations and in enclosed containers, making it easier for law enforcement to identify and prevent illegal firearm assembly and trafficking.

The bill's provisions for defining prohibited persons and establishing enhanced penalties for violations will provide law enforcement with stronger tools to combat illegal firearm

possession and assembly. These measures align with our ongoing efforts to prevent gun violence and maintain public safety in Hawaii.

The proposed regulations will significantly aid law enforcement in preventing the illegal manufacture and possession of firearms while ensuring legitimate firearm owners can comply with reasonable safety requirements.

I am submitting this testimony on behalf of myself and the thousands of members of the Hawaii Rifle Association to **strongly oppose** House Bill 279. While reducing violent crime is a priority we all share, this bill **overreaches in its attempt to criminalize lawful gun ownership, conflicts with constitutional rights, and creates legal ambiguities that can lead to unjust prosecutions.**

1. Overly Broad and Unconstitutional Provisions

A. Criminalization of Lawful Firearm Ownership

- H.B. 279 **criminalizes the mere possession of firearm parts**, even when those parts are legally owned and not assembled into a functional firearm.
- This violates **fundamental due process rights** by **punishing intent rather than action**. A law-abiding gun owner carrying parts for repairs, transport, or customization could be unfairly prosecuted **despite not violating any actual firearm regulations**.

B. Second Amendment Concerns

- Under *New York State Rifle & Pistol Association v. Bruen* (2022), firearm regulations must **align with historical traditions**. There is **no historical precedent** for criminalizing the mere possession of gun parts or components.
 - **Firearms in “common use” are protected under the Second Amendment** (*District of Columbia v. Heller*, *McDonald v. Chicago*). This bill **effectively bans lawful firearm ownership by criminalizing the very components necessary for their function**.
 - By imposing **unnecessary and excessive restrictions**, H.B. 279 could **fail constitutional scrutiny in court**.

2. Ambiguous and Unenforceable Definitions

- The bill **fails to clearly define what constitutes an “unsecured” firearm part** and does not specify **which parts** would trigger legal consequences.

- Many firearm components (e.g., barrels, triggers, grips) **are not inherently dangerous** and have legitimate uses, such as sporting, hunting, and repair.
 - The **vagueness** of this bill opens the door for **subjective enforcement**, increasing the risk that **lawful gun owners could be unfairly targeted**.

3. Ignores Root Causes of Crime and Public Safety Issues

- **Criminals already ignore firearm laws.**
 - This bill **will not stop violent offenders from acquiring firearms through illegal means**, just as existing gun laws **do not deter criminals from obtaining illegal guns**.
 - Law-abiding citizens, not criminals, will **bear the brunt of enforcement under this bill**.
 - **Focus Should Be on Enforcing Existing Laws**
 - Hawaii already has **strict gun laws**, including background checks, registration, and permits-to-purchase requirements.
 - Rather than adding **new vague and overreaching regulations**, the state should **ensure proper enforcement of existing laws against those who illegally possess firearms**.
 - **Youth Crime Requires Social Solutions, Not More Laws**
 - The bill cites **youth involvement in gun crime** as justification for banning firearm parts, but **youth offenders typically obtain firearms illegally**.
 - The state should **invest in programs that address gang violence, social instability, and family intervention**—not broad laws that **restrict law-abiding citizens' rights**.

4. Unintended Consequences for Law-Abiding Gun Owners

- **Gun Owners Transporting or Repairing Firearms May Be Wrongfully Criminalized**
 - H.B. 279 **does not exempt gunsmiths, hobbyists, or competitive shooters** who frequently **transport firearm parts for legitimate reasons**.
 - Lawful individuals who **disassemble firearms for cleaning, repair, or safe transport could be subject to arrest**, even if their intent is legal and responsible.
 - **Potential for Abuse in Enforcement**
 - The **broad and vague nature** of this bill **invites selective prosecution**, disproportionately impacting responsible gun owners rather than actual criminals.
 - It risks creating a **legal trap for ordinary citizens** who inadvertently violate unclear provisions.

5. Alternative Approaches That Address the Real Problem

Rather than imposing **unconstitutional and excessive restrictions** on lawful gun owners, Hawaii should **focus on crime prevention strategies that actually work**:

✓ **Target Criminal Possession, Not Parts** – Strengthen enforcement against **straw purchasers and illegal gun traffickers** who supply firearms to criminals.

✓ **Expand Community-Based Intervention Programs** – Invest in **youth diversion programs and mental health initiatives** to address **root causes of gun violence**.

✓ **Improve Law Enforcement Resources** – Ensure police have **adequate tools and funding** to investigate **illicit gun sales and gang activity**, rather than diverting resources to **harassing lawful owners over firearm parts**.

Conclusion

H.B. 279 is an **unnecessary and unconstitutional overreach** that **criminalizes lawful gun owners while failing to address the root causes of violent crime**. The bill **conflicts with Second Amendment rights, relies on vague and overbroad definitions, and introduces legal uncertainties that could result in unjust prosecutions**.

For these reasons, I **strongly urge the Legislature to reject H.B. 279** and instead pursue policies that effectively target **criminal behavior without infringing on the rights of law-abiding citizens**.

Hawaii House Bill 279

Support If Amended

The Motion Picture Association (MPA) respectfully requests that House Bill 279, to regulate firearms parts, be amended to ensure that any new subsection created by this bill falls within the existing exemption of Hawaii Revised Statutes §134-11(c) for the use of prop firearms in the production of motion pictures. MPA's members are the leading producers and distributors of filmed entertainment across all platforms, including motion picture theaters, cable, satellite, broadcast and internet exhibition. MPA's members include: Amazon Prime/MGM Studios, The Walt Disney Studio Motion Pictures, Netflix Studios, Paramount Pictures, Sony Pictures Entertainment, Universal City Studios and Warner Bros.

In the production of motion pictures, and television and streaming programs, prop firearms are utilized to lend authenticity to the story. And, Hawaii law recognizes the that prop firearms and blank ammunition can be an important element of a production, by affording an exemption from most restrictions on the use of guns, as long as they are prop firearms. Section 134-11(c) states:

Sections 134-8, 134-9, and 134-21 to 134-27, shall not apply to the possession, transportation, or use, with blank cartridges, of any firearm or explosive solely as props for motion picture film or television program production when authorized by the chief of police of the appropriate county pursuant to section 134-2.5 and not in violation of federal law.

To the extent that HB 279 creates a new subsection of §134 of the Hawaii Revised Code, we respectfully request that the new subsection be included in exemption provided in §134-11(c).

I stand in **STRONG OPPOSITION** to this bill. It is downright moronic to think that the police cannot enforce current laws that prevent criminals from carrying guns just because the bad guy takes his gun apart before the cops get there. Simply taking a gun apart does not make it suddenly legal to carry around.

Federal Law already considers the receiver (the frame that contains most if not all of the parts of a firearm) of a gun to be the legal firearm. As long as the receiver is intact it is considered a firearm regardless of whether it can be fired or not. There are even laws regarding what must be done for a receiver to be considered 'inoperable', even if you were to just cut a receiver in half it would still be legally considered a functional firearm. This means if I were to take my gun completely apart and walk around with just the receiver (without a valid CCW permit) I would be breaking the law already.

If a convicted felon is walking around with gun parts, it's a reasonable suspicion to think that they are in illegal possession of a firearm and a proper investigation can be done. If prosecutors or police think they cannot charge violators under current laws, then they need either be retrained or terminated from their duties since they cannot carry them out in a competent manner. Not having laws passed that makes it even easier for them to do their jobs when it should already be cut and dry.

At this point it is hard to tell the difference between incompetence and malice when it comes to enforcing the laws of this state.

The language in HB 279 creates uncertainty regarding the transport of firearm parts, making it difficult for responsible gun owners to comply with the law without fear of inadvertently violating ambiguous provisions. Law enforcement will also face challenges in applying these new regulations fairly and consistently.

Rather than imposing additional penalties and restrictions on law-abiding gun owners, the Legislature should focus on addressing the root causes of firearm-related crime, such as illegal trafficking and criminal misuse of firearms. I am submitting this testimony in **strong opposition** to HB 279, which proposes sweeping changes to Hawaii's firearm laws, specifically targeting the possession and transportation of firearm parts.

Key Concerns with the Proposed Bill:

1. Overreach and Criminalization of Law-Abiding Citizens:

The bill unfairly targets responsible, law-abiding gun owners by imposing strict regulations on the possession and transportation of firearm parts. Many individuals involved in lawful activities such as hunting, sport shooting, and firearm repair could unintentionally violate these complex rules, leading to harsh penalties for actions that pose no public safety threat.

2. Misrepresentation of Current Law:

The bill asserts that "state and county law enforcement are unable to bring charges against an individual in possession of a deconstructed firearm," labeling this as a loophole. This statement is **false**. Hawaii law **already covers firearm receivers and ghost guns** (firearms without serial numbers), making it **illegal to possess these items in public**. The real issue lies not in the law itself but in the **unwillingness of certain prosecutors to bring charges**, often under the mistaken belief that convictions are unattainable. This bill seeks to fix a problem that does not exist within the legal framework but rather within prosecutorial discretion.

3. Mandatory Minimum Sentences Are Excessive:

Mandatory sentencing removes judicial discretion, failing to account for individual circumstances. The proposed penalties, including mandatory prison time for technical violations, are disproportionate and could result in the incarceration of individuals with no criminal intent.

4. Vague Definitions and Ambiguities:

The bill's language around "firearm parts" and "enclosed containers" is vague, leaving

too much room for subjective interpretation. This could lead to inconsistent enforcement and confusion among responsible gun owners trying to comply with the law.

5. **Ineffectiveness Against Criminals:**

Criminals who intend to commit violence will not be deterred by these laws. Instead, the bill places an undue burden on legal gun owners while doing little to address the root causes of gun violence. It is unrealistic to believe that individuals engaged in criminal activity will comply with regulations on firearm parts.

6. **Potential Constitutional Conflicts:**

The bill may infringe upon Second Amendment rights by severely restricting the lawful possession and transportation of firearm components. In *District of Columbia v. Heller* (2008), the U.S. Supreme Court affirmed that the right to keep and bear arms includes the ability to have firearms in operable condition for lawful purposes, such as self-defense.

Proposed Alternatives:

- **Focus on Criminal Behavior:** Target individuals who use firearms to commit crimes rather than those engaged in lawful activities.
- **Education and Training:** Promote firearm safety and responsible ownership through education, not punitive legislation.
- **Judicial Discretion:** Allow courts to consider individual circumstances rather than imposing mandatory minimum sentences.

Conclusion:

While I understand the intent to reduce gun violence, this bill overreaches, penalizes law-abiding citizens, and risks constitutional violations. Public safety can be improved through targeted enforcement against actual criminal behavior, community engagement, and firearm education programs, not through broad restrictions that burden responsible gun owners.

3. Penalizing Non-Criminal Behavior The proposal assumes that anyone carrying firearm parts without an enclosed container is engaging in or preparing for criminal activity. This approach disregards the legitimate reasons individuals may possess such parts, such as home repairs, modifications, and lawful assembly under existing firearm regulations. The law should focus on punishing criminal misuse of firearms rather than broadly restricting lawful ownership and transportation of firearm parts.

4. Ineffectiveness Against "Ghost Guns" The bill's focus on ghost guns ignores the fact that individuals who seek to illegally obtain firearms through illicit means, including 3D printing and illegal sales, will not be deterred by additional regulations on parts possession. Instead, efforts should be directed toward targeting illegal firearm trafficking, improving mental health resources, and strengthening penalties for those who use firearms in the commission of violent crimes.

Conclusion While I support efforts to reduce crime and enhance public safety, this proposal overreaches and penalizes law-abiding citizens without effectively addressing the problem of gun violence. The proposed bill, which seeks to regulate the carrying and possession of firearm parts by restricting their transport to specific locations and requiring an enclosed container, represents a direct and unconstitutional infringement on the Second Amendment. Additionally, it imposes unnecessary and arbitrary restrictions on law-abiding citizens while failing to address criminal misuse of firearms. Recent Supreme Court decisions, particularly *New York State Rifle & Pistol Association, Inc. v. Bruen* (2022),* provide a clear legal standard for evaluating such regulations, and this proposal does not meet that test.

The Second Amendment states that “the right of the people to keep and bear Arms, shall not be infringed.” The Supreme Court’s decision in *Bruen* reaffirmed that firearm regulations must be “consistent with the Nation’s historical tradition of firearm regulation.” This means that any restriction lacking historical precedent is unconstitutional.

1. No Historical Basis for Restricting Firearm Parts

- The regulation of firearm components, including limitations on where and how they may be possessed or transported, lacks any historical tradition from the time of the Founding.
- *Heller* (2008) held that the Second Amendment protects arms “in common use,” and *Bruen* expanded upon this principle, requiring regulations to be justified by historical precedent.
- Firearm parts—such as barrels, triggers, and magazines—are integral to maintaining, repairing, and customizing firearms for lawful purposes, including self-defense and sport shooting. Restrictions on their transport and possession serve only to burden law-abiding gun owners without legitimate constitutional justification.

2. Unlawful and Arbitrary Transport Restrictions

- Restricting the carrying and possession of firearm parts to “specific locations” and requiring them to be enclosed in a container imposes an undue burden on lawful gun owners.

- There is no historical tradition of requiring firearms or their components to be transported in a particular manner, making this restriction unconstitutional under Bruen.

- The law would criminalize otherwise lawful activities, such as gunsmithing, competitive shooting, and firearms training, by imposing arbitrary limitations on how firearm parts are moved between locations.

3. Increased Penalties for Lawful Conduct

- By increasing penalties for the mere possession or transport of firearm parts outside government-approved locations, this bill turns ordinary citizens into criminals for exercising their constitutional rights.

- The Bruen decision specifically rejected interest-balancing approaches that weigh public safety concerns against constitutional rights, emphasizing that the Second Amendment cannot be subjected to a lesser level of scrutiny.

The Bruen ruling set a clear standard: gun control laws must be deeply rooted in historical tradition. This proposed bill fails that test because:

- There is no historical precedent for restricting firearm parts or imposing transport limitations.

- The government cannot impose broad restrictions on lawful gun owners without demonstrating a direct connection to historical firearm regulations.

- The penalties imposed are not narrowly tailored to criminal misuse of firearms but instead burden lawful possession and transportation.

Conclusion

This bill is an unconstitutional overreach that imposes undue restrictions on law-abiding gun owners while failing to align with historical firearm regulations as required by Bruen. By limiting where and how firearm parts can be carried or transported, it directly infringes upon the Second Amendment. Rather than imposing arbitrary restrictions, lawmakers should focus on enforcing existing laws that target criminal misuse of firearms. Given the Supreme Court's

strong stance on protecting gun rights, this bill is likely to face significant legal challenges and should be rejected outright.

HB279, in its current form, represents a disproportionate and unnecessary expansion of government authority, effectively making criminals out of law-abiding citizens for acts as simple as making a stop during a long journey. I urge lawmakers to reconsider this bill, as it not only creates unnecessary legal risks for gun owners but also fails to address the underlying issues of gun violence or safety in a practical and effective manner.

Aloha,

I am here to express my vehement opposition to House Bill HB279, a piece of legislation that I believe severely undermines the Second Amendment rights of Hawaii's citizens. Legal Precedents and Judicial Review: Recent legal trends, particularly in the Ninth Circuit with cases like *Young v. Hawaii* and *Teter v. Lopez*, have been moving towards affirming broader Second Amendment rights, even in states with historically stringent gun laws like

Hawaii. HB279 seems to ignore these judicial directions, setting up the state for potential legal challenges that could be both costly and ultimately fruitless.

Every single example provided in Section I highlights individuals disregarding existing law. I am writing to express my strong opposition to HB279, which imposes additional restrictions on the possession and transportation of firearm parts and significantly increases penalties for lawful gun owners who unintentionally violate its provisions. This bill is not only an unconstitutional overreach of government power but also a direct infringement on my rights as protected under the Second Amendment of the United States Constitution.

The Supreme Court has affirmed in **District of Columbia v. Heller (2008)** and **New York State Rifle & Pistol Association v. Bruen (2022)** that the right to keep and bear arms is an individual right. The broad and vague restrictions imposed by HB279 infringe upon this right by criminalizing the mere possession of firearm parts outside narrowly defined areas. Law-abiding gun owners should not be treated as criminals for exercising a fundamental constitutional right

Even for first-time violations, the bill imposes a ****mandatory term of imprisonment of at least one year**** for carrying a firearm outside the prescribed areas. This kind of punishment is disproportionate, unjust, and does not serve public safety.

The justification for HB279 is rooted in concerns about "ghost guns" and firearm-related crime, yet this bill does little to target actual criminals. Instead, it restricts the rights of law-abiding gun owners who have no intent to commit crimes. Criminals who obtain firearms illegally and use them unlawfully are not going to abide by the transport and storage requirements imposed by this bill.
