STATEMENT OF PURPOSE

RS32662 / S1173

This appropriation to the Department of Juvenile Corrections provides enhancements to the FY 2026 maintenance budget that includes funding for radio system upgrade and replacement, substance use disorder residential treatment program, replacement items, and IT replacement items. This appropriation also removes 7.00 FTP and includes a net-zero transfer of appropriation from personnel costs into operating expenditures for the IT modernization initiative.

FISCAL NOTE

This appropriation provides an additional \$1,057,600 to the maintenance appropriation provided to public safety agencies in Senate Bill 1107. Table 1 shows incremental adjustments to the budget found in the bill, of which the ongoing increase is \$300,000 and \$757,600 is onetime. Table 2 shows all the adjustments leading to the FY 2026 Total Appropriation. The total budget for the Department of Juvenile Corrections is \$61,320,800.
