BY JUDICIARY, RULES, AND ADMINISTRATION COMMITTEE

AN ACT

1 RELATING TO JUDICIAL DISTRICTS; AMENDING SECTION 1-804, IDAHO CODE, TO  
2 INCREASE THE NUMBER OF JUDGES IN THE THIRD JUDICIAL DISTRICT AND TO IN-  
3 CREASE THE RESIDENT CHAMBERS IN CANYON COUNTY; AMENDING SECTION 1-805,  
4 IDAHO CODE, TO INCREASE THE NUMBER OF JUDGES IN THE FOURTH JUDICIAL  
5 DISTRICT AND TO INCREASE THE RESIDENT CHAMBERS IN ADA COUNTY; AMEND-  
6 ING SECTION 1-808, IDAHO CODE, TO INCREASE THE NUMBER OF JUDGES IN THE  
7 SEVENTH JUDICIAL DISTRICT AND TO PROVIDE ONE RESIDENT CHAMBERS IN JEF-  
8 FERSON COUNTY; AND PROVIDING AN EFFECTIVE DATE.

10 Be It Enacted by the Legislature of the State of Idaho:

11 SECTION 1. That Section 1-804, Idaho Code, be, and the same is hereby  
12 amended to read as follows:

13 1-804. THIRD DISTRICT -- NUMBER OF JUDGES -- RESIDENT CHAMBERS. (1)  
14 The third judicial district shall consist of the counties of Adams, Washing-  
15 ton, Payette, Gem, Canyon and Owyhee.

16 (2) The third judicial district shall have ~~six~~ seven (~~6~~7) district  
17 judges.

18 (3) Resident chambers of the district judges of the third judicial dis-  
19 trict shall be established as follows:

20 (a) One (1) resident chambers shall be established in Washington or  
21 Payette County.

22 (b) ~~Five Six~~ (~~5~~6) resident chambers shall be established in Canyon  
23 County.

24 SECTION 2. That Section 1-805, Idaho Code, be, and the same is hereby  
25 amended to read as follows:

26 1-805. FOURTH DISTRICT -- NUMBER OF JUDGES -- RESIDENT CHAMBERS. (1)  
27 The fourth judicial district shall consist of the counties of Valley, Boise,  
28 Ada and Elmore.

29 (2) The fourth judicial district shall have ~~ten~~ eleven (~~10~~11) district  
30 judges.

31 (3) Resident chambers of the district judges of the fourth judicial  
32 district shall be established as follows:

33 (a) ~~Nine Ten~~ (~~9~~10) resident chambers shall be established in Ada  
34 County;

35 (b) One (1) resident chambers shall be established in Ada or Elmore  
36 County.

37 SECTION 3. That Section 1-808, Idaho Code, be, and the same is hereby  
38 amended to read as follows:

1           1-808. SEVENTH DISTRICT -- NUMBER OF JUDGES -- RESIDENT CHAMBERS. (1)  
2 The seventh judicial district shall consist of the counties of Lemhi,  
3 Custer, Butte, Clark, Fremont, Jefferson, Madison, Teton, Bonneville and  
4 Bingham.

5           (2) The seventh judicial district shall have ~~five~~ six (56) district  
6 judges.

7           (3) Resident chambers of the district judges of the seventh judicial  
8 district shall be established as follows:

9           (a) One (1) resident chambers shall be established in Madison County;

10          (b) One (1) resident chambers shall be established in Bingham County;

11          (c) Three (3) resident chambers shall be established in Bonneville  
12 County;

13          (d) One (1) resident chambers shall be established in Jefferson County.

14           SECTION 4. This act shall be in full force and effect on and after Octo-  
15 ber 1, 2013.
