HOUSE BILL NO. 200

AN ACT

1 RELATING TO THE APPROPRIATION TO THE PUBLIC HEALTH DISTRICTS FOR FISCAL YEAR  
2 2020; APPROPRIATING MONEYS TO THE PUBLIC HEALTH DISTRICTS AND TRANSFER-  
3 RING MONEYS FROM THE GENERAL FUND TO THE PUBLIC HEALTH TRUST FUND FOR  
4 FISCAL YEAR 2020; APPROPRIATING MONEYS TO THE PUBLIC HEALTH DISTRICTS  
5 FROM THE IDAHO MILLENNIUM INCOME FUND FOR FISCAL YEAR 2020; PROVIDING  
6 FUNDING TO IMPROVE HEALTH TRANSFORMATIONS; AND PROVIDING FUNDING FOR  
7 CITIZEN REVIEW PANELS.

9 Be It Enacted by the Legislature of the State of Idaho:

10 SECTION 1. There is hereby appropriated to the Public Health Districts  
11 and the State Controller shall transfer \$9,887,900 from the General Fund to  
12 the Public Health Trust Fund in accordance with the provisions of Section  
13 39-425, Idaho Code, for the period July 1, 2019, through June 30, 2020.

14 SECTION 2. There is hereby appropriated to the Public Health Districts  
15 \$768,900 from the Idaho Millennium Income Fund for the period July 1, 2019,  
16 through June 30, 2020, for the purpose of no-cost cessation services to Ida-  
17 hoans who want to quit tobacco use, with a primary emphasis on youth and preg-  
18 nant women. These moneys shall not be considered general state aid for the  
19 purpose of Section 39-425, Idaho Code.

20 SECTION 3. IMPROVING HEALTH TRANSFORMATIONS. Of the amount appropri-  
21 ated in Section 1 of this act, \$119,400 shall be distributed to Public Health  
22 District 4 for the purpose of improving health transformations. These mon-  
23 eys shall not be considered general state aid for the purpose of Section  
24 39-425, Idaho Code, and shall not be allocated through a board of trustees  
25 formula pursuant to Section 39-411, Idaho Code.

26 SECTION 4. CITIZEN REVIEW PANELS. Of the amount appropriated in Section  
27 1 of this act, \$136,500 shall be distributed to each Public Health District  
28 at one-seventh (1/7) of the total amount, which shall be used for the Citizen  
29 Review Panels pursuant to Senate Bill No. 1341, as enacted by the Second Reg-  
30 ular Session of the Sixty-fourth Idaho Legislature. These moneys received  
31 by the Public Health Districts shall not be considered general state aid for  
32 the purpose of Section 39-425, Idaho Code, nor shall the moneys be allocated  
33 through a board of trustees formula pursuant to Section 39-411, Idaho Code.
