AN ACT

1 APPROPRIATING ADDITIONAL MONEYS TO THE DEPARTMENT OF HEALTH AND WELFARE FOR
2 THE BENEFIT PAYMENTS PROGRAM FOR FISCAL YEAR 2015; REDUCING THE APPRO-
3 PRIATION TO THE DEPARTMENT OF HEALTH AND WELFARE FOR INDIRECT SUPPORT
4 SERVICES FOR FISCAL YEAR 2015; APPROPRIATING ADDITIONAL MONEYS TO THE
5 DEPARTMENT OF HEALTH AND WELFARE FOR INDIRECT SUPPORT SERVICES FOR FIS-
6 CAL YEAR 2015; AND DECLARING AN EMERGENCY.

8 Be It Enacted by the Legislature of the State of Idaho:

9 SECTION 1. In addition to the appropriation made in Section 1, Chapter
10 328, Laws of 2014, and any other appropriation provided for by law, there is
11 hereby appropriated \$3,236,300 from the Cooperative Welfare (Federal) Fund
12 to the Department of Health and Welfare for the Benefit Payments Program, to
13 be expended for trustee and benefit payments, for the period July 1, 2014,
14 through June 30, 2015.

15 SECTION 2. Notwithstanding any other provision of law to the contrary,
16 the appropriation made to the Department of Health and Welfare for Indirect
17 Support Services, in Section 1, Chapter 289, Laws of 2014, from the Cooper-
18 ative Welfare (General) Fund, is hereby reduced by \$1,300,000 for personnel
19 costs, for the period July 1, 2014, through June 30, 2015.

20 SECTION 3. In addition to the appropriation made in Section 1, Chap-
21 ter 289, Laws of 2014, and any other appropriation provided for by law, there
22 is hereby appropriated to the Department of Health and Welfare for Indirect
23 Support Services, the following amounts to be expended for the designated
24 expense classes, from the listed funds for the period July 1, 2014, through
25 June 30, 2015:
