HOUSE BILL NO. 244

BY APPROPRIATIONS COMMITTEE

AN ACT

1 APPROPRIATING ADDITIONAL MONEYS TO THE OFFICE OF ENERGY RESOURCES FOR FIS-  
2 CAL YEAR 2011; TRANSFERRING MONEYS TO THE GENERAL FUND; APPROPRIATING  
3 MONEYS TO THE OFFICE OF ENERGY RESOURCES FOR FISCAL YEAR 2012; LIMIT-  
4 ING THE NUMBER OF AUTHORIZED FULL-TIME EQUIVALENT POSITIONS; PROVIDING  
5 NON-GENERAL FUND REAPPROPRIATION FOR FISCAL YEAR 2012; AND DECLARING AN  
6 EMERGENCY.

8 Be It Enacted by the Legislature of the State of Idaho:

9 SECTION 1. In addition to the appropriation made in Section 1, Chapter  
10 73, Laws of 2010, and any other appropriation provided for by law, there is  
11 hereby appropriated from the listed fund to the Office of Energy Resources,  
12 the following amounts to be expended for the designated expense classes, for  
13 the period July 1, 2010, through June 30, 2011:

20 SECTION 2. There is hereby appropriated and the State Controller shall  
21 transfer, as soon as practicable, the remaining unencumbered and unexpended  
22 balance from the Idaho Economic Development Biofuel Infrastructure Matching  
23 Fund to the General Fund, for the period July 1, 2010, through June 30, 2011.  
24 The balance of the Matching Fund including accrued interest is estimated at  
25 \$99,500.

26 SECTION 3. There is hereby appropriated to the Office of Energy Re-  
27 sources, the following amounts to be expended for the designated expense  
28 classes, from the listed funds for the period July 1, 2011, through June 30,  
29 2012:

13 SECTION 4. FTP AUTHORIZATION. In accordance with Section 67-3519,  
14 Idaho Code, the Office of Energy Resources is authorized no more than eigh-  
15 teen (18) full-time equivalent positions at any point during the period July  
16 1, 2011, through June 30, 2012, unless specifically authorized by the Gover-  
17 nor. The Joint Finance-Appropriations Committee will be notified promptly  
18 of any increased positions so authorized.

19 SECTION 5. NON-GENERAL FUND REAPPROPRIATION AUTHORITY. There is hereby  
20 reappropriated to the Office of Energy Resources the unexpended and unen-  
21 cumbered balance of any American Reinvestment Fund moneys and any stimulus-  
22 related Indirect Cost Recovery Fund moneys reappropriated for fiscal year  
23 2011, to be used for nonrecurring expenditures only, for the period July 1,  
24 2011, through June 30, 2012. Furthermore, pursuant to Section 67-3511(2),  
25 Idaho Code, the Office of Energy Resources is expressly authorized to trans-  
26 fer up to \$331,100 in spending authority from personnel costs reappropri-  
27 ated from stimulus-related Indirect Cost Recovery Fund moneys to the Ameri-  
28 can Reinvestment Fund to properly account for direct personnel costs.

29 SECTION 6. An emergency existing therefor, which emergency is hereby  
30 declared to exist, Sections 1 and 2 of this act shall be in full force and ef-  
31 fect on and after passage and approval.
